

**ORDINANCE NO. 2023-06**

**ORDINANCE LEVYING AND ASSESSING TAXES  
OF THE LEYDEN FIRE PROTECTION DISTRICT,  
COOK COUNTY, ILLINOIS FOR 2023**

**BE IT ORDAINED** by the Board of Trustees of the Leyden Fire Protection District, Cook County, Illinois, as follows:

**Section One:** That the sum of **TWO MILLION EIGHT HUNDRED AND SIXTY-THREE THOUSAND TWO HUNDRED AND TEN DOLLARS AND NO CENTS (\$2,863,210.00)** be assessed and levied from and against all taxable property within the limits of the said Leyden Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2023, and the specific amounts hereby levied are set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:

**CORPORATE FUND**

Corporate Fund Levy \$ 955,738.00

The foregoing amount is hereby levied for general corporate purposes and is made pursuant to 70 ILCS 705/14.

**AMBULANCE FUND**

Ambulance Fund Levy \$ 685,705.00

The foregoing amount is hereby levied for the purpose of providing emergency ambulance service under and pursuant to the provisions of 70 ILCS 705/22.

**TORT LIABILITY FUND**

Liability Insurance Fund Levy \$ 58,480.00

The foregoing amount is hereby levied for tort liability purposes pursuant to the provisions of 745 ILCS 10/9-107.

**SOCIAL SECURITY/MEDICARE FUND**

Social Security/Medicare Fund Levy \$ 5,681.00

The foregoing amount is hereby levied for social security purposes pursuant to the provisions of 40 ILCS 5/21-110 and 40 ILCS 5/21-110.1.

**AUDIT FUND**

Audit Fund Levy \$ 5,015.00

The foregoing amount is hereby levied for audit expense purposes and pursuant to the provisions of 50 ILCS 310/9.

**EMERGENCY AND RESCUE FUND**

Emergency & Rescue Fund Levy \$ 102,590.00

The foregoing amount is hereby levied for audit expense purposes and pursuant to the provisions of 70 ILCS 705/24.

**WORKERS' COMPENSATION FUND**

Workers' Compensation Fund Levy \$ 41,100.00

The foregoing amount is hereby levied for workers' compensation expense purposes and pursuant to the provisions of 820 ILCS 305/1.

**PENSION FUND**

Pension Fund Levy \$ 1,008,901.00

The foregoing amount is hereby levied for audit expense purposes and pursuant to the provisions of 40 ILCS 5/4-118. Of this amount, the sum of \$26,518.00 is exempt from PTELL pursuant to 35 ILCS 200/18-185.

**Section Three:** If any item or portion of this Ordinance is for any reason held invalid, such decision shall not affect the validity of remaining portions of the Ordinance.


**Section Four:** That this Ordinance shall be in full force and effect from and after its passage and approval as required by law.


