The President's Pen

As the 2026 horse show season begins, the South Carolina Walking Horse Association does so from a position of strength. Through disciplined financial management, decisive governance, and deliberate action by the Board of Directors, SCWHA is stable, prepared, and moving forward with purpose.

Financial Strength and Stewardship

The Association closed the 2025 financial year solidly in the black, establishing a strong foundation for 2026. This result reflects careful cost control, effective fundraising, and a continued commitment to fiscal responsibility. Profitable fundraisers included the Membership Calendar (\$5,500), Silent Auctions held at the Awards Gala and Championship Show (\$3,100), the Motor Scooter Raffle (\$3,200), the Low Country Classic (\$2,900), and the Championship Show (\$3,250).

By maintaining low operating and horse show management costs, the Board carried 2025 profits forward, giving the Association flexibility and momentum as the new season begins.

2025 Accomplishments

In 2025, the Board of Directors delivered measurable results. The Association provided Tennessee Walking Horses for the SC 4-H/FFA Horse Judging Competition in Clemson, reestablished the SCWHA Spring Show—the Low Country Classic—in conjunction with the Rosewood Crawfish Festival, and awarded a \$1,000 scholarship to Chelsea Cook in support of continuing education. The Board also successfully relocated the SC Championship Show to the South Carolina Fairgrounds in Columbia, supported the Big Red Barn through proceeds raised at the Championship Show, and affiliated with 17 horse shows for participation in the SCWHA High Point Program.

Strategic Priorities for 2026

The Board has set clear priorities for the year ahead. These include addressing cost pressures impacting local one-night horse shows while strengthening Saturday night competition, implementing a sponsorship program to better support affiliated shows, and increasing entries and participation at SCWHA-managed events. We will continue to expand the High Point Program by encouraging membership and participation beyond South Carolina, while also supporting legal defense efforts through targeted fundraising initiatives and horse show entry fee allocations.

Key Dates

The Low Country Classic will be held on Saturday, May 2, 2026, and the SC Championship Show will take place October 30–31, 2026, at the South Carolina Fairgrounds in Columbia.

SCWHA enters 2026 with financial stability, defined priorities, and strong leadership. We remain focused on protecting the future of our industry while delivering value to our members. I look forward to the season ahead and continued progress for the Association.

3. Increase the SCWHA membership base to expand the high point program and association horse shows.
4. Advocate for equitable unity across the industry.



Legal Defense Funding

The Tennessee Walking Horse industry is once again at a pivotal moment. With **two** active lawsuits currently requiring funding and the **PAST Act** returning to consideration in Washington, strong legal representation and experienced lobbyists are essential to protecting our industry.

In addition to these immediate cases, **several** remaining lawsuits still must be adjudicated and brought across the finish line, including challenges involving the **scar rule**, **due process protections**, and the **preservation of the DQP program**. These cases are critical to ensuring fair enforcement and the long-term sustainability of the Tennessee Walking Horse.
