The video showed the 6 men surrounding my son and we wanted to make sure that somewhere in the police reports it was noted that 1 from the 5 who were not on the ground but surrounded the initial altercation kicked my son and Mrs. Wilk Ivie's grandson back to the ground as he initially tried to get up. We also wanted it noted in the police report that the video showed that my husband and Mrs. Wilk Ivie's son, Mark Ivie Sr. was on the video not only immediately, but numerous times pointing his hand in a motion that was evidence that he had

immediately, as the homeonwer, demanded the 6 leave his property to which all 6 refused. We wanted to make sure that the initial attack was investigated to determine that the individual who had my son and Wick Ivie's grandson on the ground for such an extended period of time, especially when the video showed he was not fighting back but was in a fetal position for more than 24 blows. Although we were not aware as much at the time because we ourselves had not done extensive video slow down or zoom since we did not have the capabilities that we know the police department did, we now know that at least 4 to 5 of these blows continued after the slowed down video footage shows Mark Ivie Jr's body going completely limp. Our request for an official complaint would have brought this to light. We also wanted to make sure that Detective XXXX look into the part of the video where Mark Ivie Jr could be seen holding his arm out after what our accusation was a 2nd or 3rd assaulter was seen taking another hit to his head and we wanted it on record that he was holding his arm out to tell the 6 that he was done and wanted the attack to end. We made it clear to Officer KKNNAN that we did not understand how all of this could be left out of the police report when it was all on video evidence. We made it clear to Officer Handan that our family felt extremely victimized by the 6 who came to our home, univited by the homeowner to commit violence against us. We made it clear the Officer MXXXXX that we believed we had a right to press charges. Officer Harlan guaranteed us that Detective Oxinn would follow up with us for the sole purpose of taking our statements but he never did. Detective Quinn was questioned about our visit at our son's trial very briefly and his response is in official court documents that he was aware we came, was aware we wanted to file a report and admitted to not following up with us. I believe this decision was intentional in order to assure his opinion of his initial report which showed incomprehensible bias and his probable cause affidavit which was an exact carbon copy of Mark Ivie Jr's affidavit.

I, we (WANTA Ivie) would like to get clarification on the functions that are within our legal rights to have filed our request for follow up to these important details of the event that were left out of Detective Quinn's report given the fact that his Affidavit of Probable cause was based on this video evidence. Evidence that we believe was intentionally omitted in order to detail a completely one sided account.

All of this video evidence was there from the beginning. Our family was victimized by these 6 individuals and have now been victimized once again by the lack of transparency of the complete events that took place on July 5, 2020.

*Please allow us grace as, through help of the Office of Attorney General and a letter dated 29 September, 2022 we were only given the specific direction to contact the internal affairs unit after apparently working backwards through different government agencies who require our local steps be taken before they are able to advise. We have been filing countless reports to countless agencies for over 2 years. Our hesitancy and fear of contacting Ephrata or Lancaster County until now has been difficult to overcome and is the only reason for the date of this complaint.
