1 ATTORNEY PODRAZA: Just stand there, Mark. 2 ATTORNEY ANDERSON: You got it? 3 **DETECTIVE QUINN:** Yep. DIRECT EXAMINATION 4 5 BY ATTORNEY PODRAZA: Good afternoon. 6 0. Α. Good afternoon. 7 would you mind saying your name for the record, 8 0. please? 9 Α. It's Mark Allen Ivie, Jr. 10 How are you doing today, Mark? 11 Q. I'm doing okay. 12 Α. Where are you from? 13 Q. Originally I'm from Utah. Α. 14 And when did you move to PA? 15 Q. 2013 I'd say. 16 Α. Did you go to school around here? Tell me 17 Q. about that. 18 Yeah, so I -- I started out in Manheim. 19 20 up till my senior year there. I came over to Ephrata in my senior year. 21 22 Q. Okay. I started there. They ended up switching me 23 24 over to Washington due to my credits, cause at Manheim they have higher credits than Ephrata, Manheim required 25

28 to graduate, Ephrata they required 24.

So I had 23 at the time. I just needed one English credit. So they transferred me over to Washington so I could get that and be done with high school.

- Q. After school what did you do for employment?
- A. At that time I was working at UPS.
- Q. Okay. And what would you like to do as a career generally?
- A. I was -- before all this happened I was actually studying to get my CDL, but with COVID the DMV gets closed down so all of that got postponed.
 - Q. Where do you live?
 - A. I live in Ephrata currently.
 - Q. Okay. Who do you live with?
 - A. I live with my dad, my stepmom and my brother.
 - Q. Okay. And what's the address for that?
 - A. It's 6 Blackberry Lane.
- Q. Okay. Do you recall the events of July 4th, 2020?
 - A. Yes, I recall.
 - Q. What do you recall about how that day started?
- A. Well, it was nothing special. I was just kind of laying in bed watching NetFlix in the morning. I let my dog out so she could use the restroom. I know I

smoked a cigarette while I was out there. I came back inside, just watching NetFlix pretty much.

- Q. Okay. How did the day progress? What did you do?
- A. Well, later on in the day my dad and my stepmom, they got home. They were out running around, getting stuff.

I know while they were out running around they bought the patio set that I mentioned. They -- my dad asked me to help him get it out of the truck and bring it in the back so I could help him set it up.

- Q. And what happened after that?
- A. Well, after that, I mean, it was me, my mom and my dad. We were all just hanging out, drinking in the pool waiting for the food to cook at this point.
 - Q. What were you cooking that day?
 - A. My dad was making a brisket.
- Q. How were you -- how would you describe the day up until that point?
 - A. I would say it was pretty good.
- Q. Okay. What -- what happened as the day progressed into night?
- A. Well, as the day progressed into night my sister and her boyfriend ended up coming home. This was probably around 5 in the afternoon.

We were all swimming in the pool. We were drinking. We were waiting for the food to be done. That ended up being around 6 or 7. We ate, and then we kind of just hung out and talked as a family. We --

- Q. And then what happened?
- A. Well, as soon as it got dark out I know we went out front and we started lighting fireworks. As -- as we were doing this I know my neighbor, she came over with her grandson so they could watch fireworks with us.
 - Q. And, now, do you use social media a lot?
 - A. Yeah, I use it.

- Q. What kind of platforms do you use?
- A. Instagram, Snapchat, Facebook.
- Q. Would you say that's pretty common for someone your age?
 - A. Yeah, I would say it's pretty common.
 - Q. Okay. Now, how do you know Randy Brandt?
 - A. I used to work with him at a car wash.
- Q. Does -- what do you know about Randy Brandt, at least in the time that you knew him?
- A. From what I picked up is what he was telling me. He was someone that was trying to pursue rap. He told a lot of stories; I don't know how correct they were. He never -- he told me stories of him rolling with the crew, hanging with his boys, selling drugs,

using drugs. 1 ATTORNEY ANDERSON: Objection, Your Honor. 2 THE COURT: Sustained. 3 ATTORNEY PODRAZA: What --4 ATTORNEY ANDERSON: I -- I would move that that 5 be stricken from the record. 6 7 THE COURT: Mr. Podraza, your response? ATTORNEY PODRAZA: Your Honor, that -- that can 8 be stricken, that part. 9 THE COURT: Members of the jury, that will be 10 stricken from the record. It will not be considered in 11 your deliberations. 12 BY ATTORNEY PODRAZA: 13 What -- what did you know -- did you have any Q. 14 encounters with him that night? 15 That night, yes. 16 Α. Okay. And what -- how did you have an 17 Q. encounter? 18 He posted a video on his Snapchat. I was 19 20 drunk. It was late at night. I was scrolling through Snapchat, I see the video and he said -- he said, let me 21 know what you think. 22 23 I was drunk, not thinking too much of it. I made a snide comment. 24

What was on -- what was on the -- the video

that you saw?

- A. It was a video of Randy rapping.
- Q. Okay. And what -- what would you describe that video as? What con -- what was the content of the rap?
- A. I would say what you describe normal rap is, the majority of it, at least; gangs, violence, drugs.
 - Q. Okay. Now, how did it proceed after that?
- A. I know he wasn't too happy with what I said so he started calling me names. I called him some in return.
- Q. And were you only talking to Randy at this point?
 - A. At this point, yes.
 - Q. Okay. What happened after that?
- A. After that, it -- we just kept going back and forth, and then I finally ended up sending him my address.
- So after that I -- I thought it was just something stupid on the internet. At this point I didn't really -- if I knew he was gonna come to my house I wouldn't have sent him my address.
- Q. Did you have any contact with anybody other than Randy?
- A. Yeah. So after I sent Randy my address his friend Josh added me on Snapchat and told me he was

gonna come to my house and inflict violence on me.

- Q. Did you know any of these other people?
- A. No, I did not at this time.

- Q. Okay. What did -- what did you tell your dad about this?
- A. I told my dad that potentially two guys were gonna come to the house, I don't know exactly what their intentions are gonna do, but it's obviously not good.
- Q. Were you surprised that they were -- that they were coming?
- A. Yeah, I was quite shocked. I didn't -- well, yeah. I was shocked when Josh went out of his way to add me on Snap just to inform me that he was going to do this.
 - Q. How did you feel about that?
- A. I was nervous, which is why I went and told my dad, asked him for help.
 - Q. What did you think was gonna happen next?
- A. Maybe -- I'm not sure, but maybe they're just doing this to scare me.
 - Q. Okay. Then what happened?
- A. Me and my father, we waited outside to see if they would come, and it ended up they did.
- Q. Okay. Now, when they arrived at their -- at your home, how many people were there?

- There were six of 'em. 1 Α. Okay. Were they men or women? 2 Q. All men. 3 Α. Q. How did they -- how old did they appear to be? 4 Around my age to mid-20s. 5 Α. Can you describe when you saw them their 6 Q. 7 appearance or mannerisms? They were walking in a crowd very fast. 8 immediately all started yelling, all started cussing. 9 What did you think at this point? 10 Q. I was scared. I wasn't expecting six men to 11 Α. show up at my house. 12 Okay. Did you end up fighting Randy? 13 Q. Α. No. 14 What ended up happening? 15 Q. His friend Josh -- cause we were all just 16 Α. throwing arguments back and forth at this point. 17 His friend Josh was in my face. He was -- he 18 got so close to the point where he -- spit was basically 19 coming out of his mouth slapping me in the face. 20 21 So I pushed him back to make some space between us because I was very uncomfortable. 22 23
 - Q. What happened next?

Α. He swung on me, and we ended up rumb -- not rumbling, like, tussling, grabbing each other, wrestling

- really at that point. We ended up going to the ground.

 He ended up over the top of me.
- Q. Okay. What happened when he was over top of you?
 - A. He hit me so many times.
 - Q. Okay. Where did he hit you?
 - A. In the face, in the body, everywhere.
 - Q. I'm going to show you a video.
 You're familiar with the video in this case?
 - A. Yes.

- Q. Can you see on that screen?
- A. Yes, I can.
- Q. What do you recognize in this first screen right here?
 - A. I can see my house across the street.
- Q. This -- what do you believe this perspective to be from?
- A. From my neighbors' house. I can clearly tell where it was from.
- Q. Now, I'm gonna play the video. You've seen this before during the Commonwealth's case.
- what do you see happening at 3745? Just give it a pause. Tell me the first thing you see when --
- A. I believe I see a group of men heading towards my house.

1	Q. Play it full screen.
2	And I'm gonna zoom at this point.
3	So can you describe what's happening at this
4	point?
5	A. At this point they approach. They were making
6	threats on my father, telling him like, not really
7	like, you won't shoot me, come on, shoot me, saying
8	stuff like that towards him.
9	Immediately calling me mean names, him names,
10	making threats.
11	Q. And who is that on the lawn up there?
12	A. That's my father.
13	Q. Now, when these men are talking to you, how are
14	they positioned?
15	A. All around us, just moving around. They didn't
16	stay in one exact spot.
17	Q. Is that consistent with what they were doing
18	throughout your encounter with them?
19	A. Yes.
20	Q. So what's happening now?
21	A. At that point, that was when I pushed Devon
22	back and he hit me.
23	Q. So now what's your understanding of what's
24	going on?
25	A. I'm on the ground getting pummeled.

Who is doing that? 1 Q. Devon, I believe. 2 Α. Did you know him at the time? 3 Q. Α. No. 4 Were you trying to fight back in this moment? 5 Q. No, I was trying to protect my face. 6 Α. was the face the only place that you had been 7 Q. hit? 8 No, but that was -- my main priority was to 9 protect that. 10 Now, what's happening now? 11 Q. I leave. I stood back up at this point and 12 Α. then arguments were thrown. 13 Were you trying to fight at any point at that 14 Q. time? 15 16 No, I was not. Α. I may have been speaking some unkind words, but 17 I was not making any aggressive mannerisms. I wasn't 18 doing anything like that. 19 What were you feeling at this point? 20 Q. I was shocked that I got beat up, a foggy head. 21 Α. 22 Q. What do you think the other guys were doing at this moment? 23 Circling, pressing, making threats still. 24 Α.

And after you got up from the ground, was

that -- what happened after that? I know I was hit again. 2 I'm going to pause it just for a moment. 3 Q. Now, when you were interviewed by detectives, 4 5 they chronicled some of your injuries; is that correct? Yeah, that's correct. Α. 6 And some of those were previously entered into 7 Q. evidence. 8 I'm gonna show some photos. Do you recognize 9 these photos? 10 Yes, I do. 11 Α. What do you recognize them to be? 12 Q. Scrapes on my back. 13 Α. Okay. When were these taken, to your 14 Q. knowledge? 15 Those were taken, I believe, after I gave my 16 statement to the police. 17 Okav. And that would have been when we were 18 0. watching the interview, around that time? 19 Yeah, after that occurred. 20 Α. Okay. And where did these injuries come from? 21 Q. Those resulted when I was on the ground and 22 Α. 23 Devon was over top of me. I was -- every time he hit me 24 my back was just grinding against the asphalt.

Were you wearing a shirt at the time?

25	Α.	I believe 1 in the morning, sometime around

1 there. So I'm gonna play the video again, but as I 2 start -- this is -- this is where we left off. 3 At this time you had been struck; is that 4 5 correct? Α. 6 Yes. Okay. Do you know who this individual is? 7 Q. The far right? I -- I can't tell you. 8 Α. Okay. Did you believe him to be one of the six 9 Q. men that came to your house that night? 10 Α. Yes. 11 Did you -- were -- where is he in relation to 12 0. you in this video? 13 I -- I think I'm more towards the sidewalk. 14 I can't quite see. 15 Okay. And where are these gentlemen in 16 0. relation to you? 17 Probably to the right of me at the time. 18 Α. Okay. I'm gonna play it. 19 Q. And again, is this consistent with what you 20 experienced that night? 21 22 Α. Yes. Now put it in full screen. 23 Q. Now, what has just happened is you've received 24 25 the firearm; is that correct?

- A. Yes, that's correct.
- Q. And you're discharging the firearm; is that correct?
 - A. Yes.

- Q. Why did you do that?
- A. I was scared. I thought this was the only option I had to make these men leave.
- Q. Why did you think it was the only option you had?
- A. Because they were continuing to verbally assault me. They -- after I was beat up, I was then hit more -- two more times. Various threats were made by different people.
- Q. And did you feel like you could get out of that situation?
 - A. No, I couldn't.
- Q. What did you think would happen if you tried to get out of that situation?
- A. If I tried to walk away, I couldn't leave my father there by himself. It's --
- Q. At the end of the day, did you want anybody to get hurt out of this situation?
 - A. No.
- Q. When you sent those messages back to Randy at that time, did you ever think something like this would

happen?

- A. No, I didn't think this would result.
- Q. Yet why did you fire?
- A. I was scared, and I didn't think I had another option. I thought that was -- in the moment these men were just vicious. They wouldn't stop.
- Q. And what did -- what did you think would happen if you didn't fire?
- A. That they were gonna continue to beat me and my father down until it wasn't capable -- capable for us to move or to do anything at that point.
- Q. What told you they weren't going to leave after they beat you up?
- A. Cause I was struck two more times. They -they were like, you're not done yet, this isn't over,
 you still got more coming, stuff like that.
- Q. And what told you that from what you just reviewed?
- A. Them not even thinking about walking away after I was clearly beat up.
 - Q. Okay. Now, how did you feel?
 - A. Terrified.
 - Q. Okay. How did you feel physically?
- A. Physically, my head was hurting, I wasn't -- I wasn't capable of continuing to fight.

- 1 Now, after this all happened did you chase any Q. of these guys down? 2 No. I didn't. 3 Α. Q. I'm gonna play the video again. 4 As you're firing, I -- what happens at this 5 point? 6 At this point I stopped firing. I believe my 7 dad was still fighting with one of the men. 8 Okay. This would be, in this general area, one 9 Q. of the men that came to your house that night, correct? 10 Α. 11 Yes. And you still have the firearm in your hand? Q. 12 That's correct. Α. 13 Okay. Did -- what did you do in that 14 Q. situation? 15 I kind of just waited for it to be over. 16 Ι don't know. I wasn't --17 Now, when the police arrived what did you do? 18 Q. I did exactly as they asked. Α. 19 20 Q. Okay. And why was that important to you? 21 Α. Cause this incident apparently was not 22 something I expected or planned. It was -- I needed the police to know that I'm not some other criminal that did 23 24 this on purpose.
 - Q. Were you hiding when the police came?

21	Q. And if you didn't do what you did, what do
22	what do you think could happen to you?
23	A. Potentially me and my father getting killed.

decision again when you chose to fire? Yes, if it was the same circumstances. Yes. 2 Α. 3 ATTORNEY PODRAZA: No further questions. THE COURT: Cross-examine. 4 ATTORNEY ANDERSON: Thank you, Your Honor. 5 Before I begin cross-examining the defendant I 6 7 would like to note, I don't think it was noted for the record, defense counsel was just showing Commonwealth 8 Exhibit 4 to the witness. 9 ATTORNEY PODRAZA: That's correct. 10 11 THE COURT: You may proceed. 12 CROSS EXAMINATION BY ATTORNEY ANDERSON: 13 Good afternoon, Mr. Ivie. 14 Q. Good afternoon. 15 Α. Now, you have been here for the entire trial, 16 Q. correct? 17 Α. That's true, yes. 18 Okay. You were arrested by Officer Kertsman 19 Q. sometime between, like, 1:45 and 2:00 in the morning. 20 Would that be accurate? 21 Yeah, that's correct. 22 Α. Okay. And you were interviewed by Detective 23 Q. 24 Quinn and by Detective Sheppard a little bit after 25 6 a.m.; is that right?

- 1 Α. Yes. In the time that you were with -- the 2 Q. time between when you were arrested and when you were 3 4 interviewed by Detective Quinn and Detective Sheppard, 5 you were taken outside so that you could smoke cigarettes; is that right? 6 In the loading bay, it wasn't outside. 7 Α. What's that? 0. 8 In the loading bay? 9 Α. 10 Q. Yes. Yeah. 11 Α. So the police took you outside so that 12 Q. you could smoke cigarettes? 13 Α. Yeah. 14 You were offered food and drink by the police? 15 Q. Water. I wasn't offered food until --16 Α. You don't remember being offered food? 17 Q. -- later in the morning. Α. 18 I'm sorry? Q. 19 I said I wasn't offered food until probably 7 20 Α. in the morning. 21 Okay. You were offered a drink, though? 22 Q.
 - A. A water, yeah.

Q. And you were treated fairly by Detective Quinn and by Detective Sheppard. Is that fair to say?

- A. Yes, I would say so.
- Q. And, in fact, in the interview that we watched, you know, they said, how would you say you were treated by us, and you said 10 out of 10.
 - A. Correct.
 - Q. And you felt that way cause it was true, right?
 - A. Yeah.

- Q. Okay. They were nice to you throughout the entire interview?
 - A. Yeah.
- Q. Was anybody that you encountered -- from the time you were arrested until the time you were interviewed by the detectives, was anybody mean to you at all?
 - A. Not the police officers, no.
 - Q. Not the police officers.
 They treated you with respect?
 - A. Yes.
- Q. Okay. And, in fact, would you agree with me that when we watched the interview that you did with Detective Quinn and Detective Sheppard they were not only nice to you but they were sympathetic with you; is that a fair characterization?
 - A. Yes.
 - Q. Okay. And they also made sure that your

injuries were documented; is that right?

A. Yes.

- Q. Okay. And the whole time you were interacting with Detective Quinn and with Detective Sheppard you knew that they were the police, right?
 - A. Yes.
 - Q. Okay. What do the police do?
 - A. Arrest people.
- Q. They arrest people. They file charges against people, right?
 - A. Yeah.
- Q. Okay. And you know that they wanted to find out from you what had happened; is that right?
 - A. Yeah.
- Q. Okay. And when you gave your statement to Detective Quinn and to Detective Sheppard, you didn't know that all of this was captured on video; is that correct?
 - A. That's correct, yes.
- Q. And they didn't tell you that it was captured on video; is that right?
 - A. Yeah.
- Q. All right. And you knew when you talked to them that it was important for you to tell them the truth, right?

3	things that you you talked about in your statement

I said, these men are coming to my house, yes. 9 These men are coming to my house. 10 Q. So you knew that there were men were coming to 11 your house and you told your dad about that? 12 Α. Correct. 13 And you specifically told your dad to get a Q. 14 gun; is that right? 15 Yeah, I asked him for help. 16 Α. And then you actually waited outside for these 17 Q. guys to show up; is that right? 18 To see if they would, yes. Α. 19 To see if they would. 20 Q. How long were you gonna stay out there? 21 I wasn't gonna wait all night for it. It 22 Α. was -- we were out there smoking cigarettes, it 23 wasn't --24

But you actually went outside because you

1 expected them to come? That's what Josh was saying to me over the 2 phone, yes. I kind of expected him to come. 3 4 And you were here when we were watching 5 Commonwealth's Exhibit Number 4, the video from your neighbors' house; is that right? 6 Correct. Yes. Α. 7 And you saw how before those guys walk up at 8 0. about 12:38, it's you standing out in front of your 9 house; is that right? 10 11 Α. Yes. And there appears to be an object in your hand, 12 **Q**. an object that lights up periodically. 13 What is that object? 14 That's my phone. Α. 15 That's your phone. 16 Q. Is that a cell phone? 17 Yes. 18 Α. Is that a cell phone capable of placing phone 19 Q. calls? 20 21 Α. Yes. Is that the same cell phone that you talked to 22 Q. Randy on? 23

Is that cell phone capable of calling 911?

- 1 Α. Yes, it is. Is it capable of calling the local police 2 Q. department? 3 Α. Yes. 4 You didn't do that, did you? 5 Q. No, because I didn't think they were actually 6 Α. 7 gonna come until they were already here. When they got there, there was nothing 8 0. that would have stopped you from placing a call to 911; 9 is that correct? 10 Is that correct? 11 12 Α. No. Okay. And am I correct that you actually 13 Q. talked to Randy when he was on his way to your house? 14 Yeah, with Snapchat, --15 Α. 16 Q. Okay. 17 Α. -- text message. And you told the detectives in your interview 18 Q. that from the time you told your dad to get the gun 19 until the time that they arrived it was approximately 25 20 to 30 minutes. 21 22 Do you remember saying that?
 - A. Yes, I remember saying that.
 - Q. Is that accurate?

A. It doesn't seem so.

1 So you said the night that it happened 0. Okav. that it was 25 to 30 minutes. 2 How long now do you say it was between the time 3 4 you told your dad to get the gun and the time that they 5 arrived? Α. 10 to 15 minutes. 6 10 to 15 minutes. Okay. 7 Q. So you wanted to have a fair fight; is that 8 correct? 9 Ultimately I was just messing around on 10 Α. Snapchat. I never thought it would result this way. 11 You were just messing around on Snapchat? 12 0. 13 Α. Yes. How often do you mess around on Snapchat or how 14 Q. often, as a result of messing around on Snapchat, do you 15 ask members of your family to arm themselves? 16 This has never happened before. 17 Α. Okay. You told the police that you expected 18 0. that there was going to be a fair fight; is that 19 20 correct? Yes, when the six of them walked up maybe I 21 22 thought. What's that? 23 0.

thought for a second that they were until they all

I said when the six men walked up maybe I

started screaming and cussing.

- Q. How's this. What you challenged Randy Brandt to was a fair fight, right?
 - A. Yes.

- Q. Okay. So as far as he's concerned, based on what you said, he should have expected a fair fight when he got there; is that right?
 - A. Yes.
- Q. Okay. And you wanted your dad to be there and to make sure that he had his gun to ensure that if there was going to be a fight, it was going to be a fair fight; is that correct?
 - A. Ultimately for my protection.
 - Q. For your protection?
- A. Yes.
- Q. But you expected there to be a fight, and you expected your dad to have your back in the event that anyone else tried to jump in; isn't that what you told the police?
 - A. Yeah, that's what I told them.
- Q. Okay. And you don't wind up fighting with Randy; is that correct?
 - A. No. I don't.
- Q. And Randy is significantly smaller than you; is that safe to say?

1 Α. Yes. How tall are you? 2 Q. Six foot. Α. 3 Q. Six foot. 4 How old are you? 5 21. Α. 6 How old were you on July 5th, 2020? 7 Q. Α. 20. 8 You were 20? 9 Q. 10 Α. Yes. Are you any taller now than you were then? 11 Q. 12 Α. No. So you didn't actually fight with Randy, 13 Q. Okay. you fought with who you now know to be Devon Schaefer; 14 15 is that right? 16 Α. Yes. And you testified a minute ago that Devon was 17 Q. in your face and that you shoved him first; is that 18 correct? 19 I pushed him. It wasn't quite a shove. 20 Α. You pushed him? 21 Q. 22 Α. Yes. So he didn't put hands on you prior to you 23 Q. putting hands on him; is that correct? 24 25 Α. No, but his spit was in my face and I was

extremely uncomfortable so I had to create space. Okay. You could have created space by taking a 2 0. step back: is that correct? 3 Α. Yeah. 4 But instead you pushed him? 5 Q (The court reporter asked for an audible 6 7 response.) THE WITNESS: Yes. 8 BY MR. ANDERSON: 9 And after you pushed him, that's when he swung 10 Q. at you; is that right? 11 Α. 12 Yes. And that's when you guys fought? 13 Q. Yeah. 14 Α. 15 Q. I mean, --It wasn't --16 Α. -- ultimately he wound up on top of you and he 17 Q. beat on you; is that correct? 18 Α. Yes. 19 Okay. But when you stood up again, when he got 20 Q. off you and you stood up, you taunted him; is that 21 correct? 22 23 Α. Yes. And what you said in your interview is true, 24 Q. 25 that you told him -- you said that he hits like a

fucking pussy; is that correct?

- A. Yeah, I might have said that.
- Q. You said that to him?
- A. I might have, yes. I don't recall those exact words, but --
- Q. You told him, you just hit me 10 to 15 times and I'm still standing here talking to you. Is that what you said?
 - A. Yes, that's correct.
- Q. Okay. So you kept antagonizing him even after he had just hit you; is that correct?
 - A. Yes.

Q. All right. And we were just looking at the video, we just had the -- the still image up there.

There was nothing physically preventing you from going up the yard and into your house at any point during that confrontation; is that correct?

- A. There was six men there. I did not feel I could walk away from them.
 - Q. Did you try?
 - A. No.
 - Q. Your dad had a gun, correct?
- A. Yes, and they made it very clear that they weren't scared of the gun.
 - Q. But there was nothing physically impeding you

from moving from the sidewalk where you were up to your house; is that correct? No, nothing physical. 0. Those men all stayed on the sidewalk and on the street; is that correct? Α. Yes. At no point did any of them step onto the grass Q. of your property; is that correct, that you saw? Α. I don't recall, no. Okay. So I want to talk about the gun. Q. You told the detectives that your dad had set the gun down on the ground and that you had picked it up. Α. Correct. Do you remember that? Q. Yes. Α. And you know now that that's not correct, Q. right? Α. Yes.

- Q. But you know that, in fact, based on what's in the video, that he actually hands it to you; is that right?
 - A. Yes, that's what it shows.
- Q. But just a few hours after the shooting, you told the detectives that he put it on the ground and you

had picked it up.

- A. I told the detectives I think he put it on the ground.
- Q. So based on your memory of how everything went a few hours after the shooting, it made sense to you that he would have set the gun on the ground and that you would have picked it up?
 - A. Thinking about everything that happened, yes.
- Q. Okay. And you would agree with me that regardless of how you got the gun, once you had that gun in your hands your dad went over and your dad attacked one of the boys that was there to -- that was there on the sidewalk; is that correct?
 - A. Yeah, he threw a punch. Yeah.
 - Q. He threw a punch at him.

And so your dad relinquished the gun, walked up to that young man and took a swing at him; is that correct?

- A. Yes.
- Q. Your dad walked up to him, he didn't walk up to your dad; is that correct?
 - A. I believe so.
 - Q. You believe so?

(The court reporter requested an audible response.)

THE WITNESS: I said I believe so. 1 BY MR. ANDERSON: 2 And you told the detectives that you started 3 Q. 4 shooting because two guys started rushing your dad; is that correct? 5 Yes, in the moment that's what I thought I saw. Α. 6 That's what you thought you saw? 7 Q. Yeah. Α. 8 You've watched the video, right? 9 Q. 10 Α. Yes. It's not on there, correct? 11 Q. No, that's not quite what happened. Α. 12 That's not quite what happened. 13 Q. But based on what you told the detectives you 14 would have opened fire to defend your dad from these --15 these people that were rushing him; is that correct? 16 17 Α. Yes. Okay. That's not what you're testifying to 18 Q. now, right? 19 No, cause after seeing the video I'm -- I 20 realized that --21 After seeing the video you realized that the 22 Q. story is different? 23 That they didn't rush exactly, they were on 24 25 their toes and they were looking like they were ready to pounce any second.

- Q. Okay. So the gun, the safety was on on that gun when your dad handed it to you; is that correct?
 - A. Yes.
 - Q. What's a safety?
 - A. It prevents the gun from firing.
- Q. Okay. It won't shoot when the safety's on, right?
 - A. Yes.
- Q. You switched the safety from the safe position to the fire position; is that correct?
- A. Yes.
- Q. And this was your first time shooting that gun; is that correct?
 - A. Yes.
- Q. And so you had to find where the safety was in order to switch it off; is that correct?
- A. I mean, yeah. I knew where it was at. It wasn't the first -- it was the first time I shot the gun, not the first time I handled the gun.

- So you knew where the safety was? 1 Q. 2 Α. Yes. And you made the decision to switch it to fire? 3 Q. Α. Yes. 4 And you knew that switching the safe --5 Q. switching the safety from safe to fire would mean if you 6 pulled the trigger a bullet was gonna come out of that 7 gun, correct? 8 Α. Yes, that's what happens. 9 Okay. And then you started shooting? 10 Q. Yes. 11 Α. Officer Kertsman came and took you into custody 12 0. within minutes of the shooting; is that correct? 13 That's correct, yes. 14 Α. You were here when we watched the video of your 15 Q. transport from your house to the Ephrata Police 16 Department, correct? 17 Α. Yes. 18 And you remembered that within minutes of --19 Q. 20
 - within minutes of the shooting you said you know that you shouldn't have done what you did; is that correct?

I mean, the way I was thinking about it was all Α. in shock so it all kind of hit me at once.

And the only thing I could decide is I probably just shot somebody. So, yes, I wasn't happy I shot

somebody.

- Q. But that's -- but that's what you said?

- Q. And then hours later, within hours of the shooting when you were being interviewed by Detective Quinn and Detective Sheppard, again, you said that you knew you shouldn't have done what you did, right?

- A. Yes, but it -- and it all hit me at that time. The reason I said it like that is cause I was thinking about what happened and not why it happened.
- Q. Okay. You fired every shot that was fired in that incident; is that correct?

- Q. You have been -- you told the detectives that you've been to a gun range before, correct?
 - A. Yes.
 - Q. About how many times have you been shooting?
 - A. I couldn't tell you an exact number.
- Q. Okay. Was it -- is that because it's very few times or is that because it's very many times?
 - A. No, it's quite common.
 - Q. So you've been to the shooting range many
