

ORDINANCE NUMBER 2023-01

BRADY TOWNSHIP, BUTLER COUNTY, PENNSYLVANIA

**AN ORDINANCE REVISING THE RECREATIONAL VEHICLE PARK/CAMPGROUND
ORDINANCE REQUIREMENTS FOR INSPECTIONS, RECORDS TO BE KEPT AND
REGISTER OF CAMPERS, AND VIOLATIONS AND PENALTIES SECTIONS.**

WHEREAS, on November 20, 2019, the Brady Township Board of Supervisors adopted Ordinance No. 2019-4, imposing regulations on campgrounds and recreational vehicle parks in the Township; and

WHEREAS, on April 21, 2021, the Board of Supervisors adopted Ordinance Number 2021-01, amending Ordinance 2019-4 in its entirety; and

WHEREAS, owners and managers of local campgrounds and recreational vehicle parks have requested that the Board of Supervisors revise certain provisions of Ordinance 2021-01; and

WHEREAS, based on the recommendations of the owners and managers, the Board of Supervisors has determined that certain revisions should be made to Ordinance 2021-01 and that the revisions are in the best interest of the Township; and

WHEREAS, the Board of Supervisors deems it necessary and appropriate to revise Ordinance 2021-01.

NOW THEREFORE IT IS HEREBY ENACTED AND ORDAINED that:

(1) Chapter 118, Campgrounds and Recreational Vehicle Parks, Section 118-10, Inspections, of the Code of the Township of Brady is hereby revised to read as follows:

A. Upon appointment with the manager of the campground or recreational vehicle park, the Township may make inspections of all such campgrounds and parks located in the Township.

B. Township inspections made in response to an identifiable complaint involving compliance with Federal, State and/or Township regulations at the campground or park, shall be made within ten (10) business days of receipt of the complaint.

C. All other Township inspections for compliance with Federal, State and Township governmental regulations shall be made between October 31 of the current year and April 1 of the following year.

D. Following any inspection, the Township inspector(s) shall report to the Board of Supervisors at its next public meeting on the conditions found at the campground or park.

(2) Chapter 118, Campgrounds and Recreational Vehicle Parks, Section 118-11. B., Violations and Penalties, of the Code of the Township of Brady is hereby revised to read as follows:

(5) The Township secretary is hereby directed to provide all campgrounds and recreational vehicle parks in the Township with a signed copy of this Ordinance.

(6) The Ordinance shall become effective five (5) days after adoption.
