

Winter Board Meeting Thursday, January 20, 2022

- I. Kevin called meeting to order at 7:03 pm
 In attendance was Kevin, Susan, Tina, Cathy, Nan, Lexi, Shayla, Tara, Charlene.
- II. Tina shared the financial status with the board members. We currently have \$40,270.33 in our checking, \$48,401.46 from our CD. In the conference account currently has \$1677.12.
- III. Cathy shared the minutes from the previous board meeting. Tara moved to approve the minutes, and Tina seconded.
- IV. President Report: Tara
 - a. 2 delegates (Karen and Cathy) and 2 alternates (Tara and Nan) need to be submitted by the end of the month.
 - b. Charter agreement needs to be submitted.
- V. Committee Reports
 - a. Nominations Report: Kevin The board decided to appoint a person for each role that wasn't filled. Cathy volunteered to fill the delegate role, and Marne Skarphol for president-elect. There is currently no Secretary.

 - c. Legislative: Kevin The ASRT is providing resources to the SDSRT to work on revising some information with the Health Board of South Dakota on opening the state rules in the language for non-registered medical professionals performing imaging.

Some examples that were brought up was revamping SDSRT merchandise, sponsoring a member to go to the ASRT National Delegate Meeting, or hosting a student specific event.
