I understand the EES equipment must not be touched by myself, my pets, children, or any other person who accompanies me. I understand the EES equipment is specifically calibrated and positioned. I agree if it is moved in any way, even accidentally, will result in a \$3,000 fee to be paid immediately, due to the fact that the equipment will need to be repaired and/or realigned/recalibrated. I also agree to inform **EES Austin** if I see any other client move or bump into the system during or in between sessions.

I am aware this is a legal **Waiver & Release** of potential liability and a binding contract between **EES Austin** and myself. I understand I am signing this contract of my own free will. ## CANCELLATION & LATE ARRIVAL POLICIES

At **EES Austin**, we understand that unanticipated events occur in everyone's life. Unforeseen events such as flight delays, car problems, traffic considerations, and unexpected business meetings, are a few reasons why one might consider cancelling a session. In an effort to provide a uniquely tailored response to each of our clients, and in consideration of the limited space we have in the EES room, we have adopted the following cancellation policy.

1. **Cancel or Reschedule.** We request a 24-hour notice in which to cancel your appointment. Use the **Cancel** or **Reschedule** button in your **original booking link** to cancel or reschedule your appointment. (Please bookmark this for quick access.) Your properly cancelled appointment will be redeposited back into your EES account. If your originally scheduled appointment is not cancelled nor filled by another client, you will be charged 50% of what you paid for the session. This fee will need to be paid before you book your next appointment.
2. **No Show.** If you fail to cancel your session within 24 hours of your actual appointment, you will forfeit the full amount paid for the appointment. Please understand that we have only ten spots/seats in our EES room, and due to the overwhelming demand of this incredible technology, there is usually a waiting list to get in. We want others to have the opportunity to take advantage of your missed opportunity.
3. **Late Arrival.** Each session has a specific start and stop time with 30-minute intervals in between each 2-hour session. Please try to arrive 20 minutes before your session so you can check in and get situated. If you arrive 20 minutes past your scheduled start time, you will be disrupting the experience of the other clients who will already be in a trance state. We regret that these late arrivals will not receive an extension of their scheduled appointment and the client will be subject to the cancellation policy stated above. In special cases and when our schedule allows, EES staff may be able to accommodate a partial appointment. This will be at our discretion and only with proper, advanced notice of your late arrival. Please note that your time is precious in the EES room, and you will not want to miss any part of your session.

For all improperly missed appointments or those not cancelled in compliance with the above conditions, those sessions will not be refunded.

## SACRED PROMISES & CODE OF ETHICS PREPARATION & FOLLOW UP INSTRUCTIONS

**By signing the 30 Sacred Promises & Code of Ethics, Preparation & Follow-Up Instructions, ensures that I understand and agree to the following:**

1. Upon arrival, I will check in at the EES counter, indicating my attendance for the session.
2. I agree to complete and returned this Waiver, Cancellation & Late Arrival Policy, Sacred Promises, Code of Conduct, Preparation & Follow-Up Instructions, before I am allowed to begin my EES session.
3. I understand for best results, my bowels need to be regular so that I am releasing toxins appropriately. I understand if I am not regular, toxins may be stirred up and have difficulty leaving my body. Therefore, if it is possible to do a colon/herbal cleanse or colonic irrigation, it will enhance my body's ability to release toxins.
4. Prior to my session, I understand it is beneficial to eat a light meal several hours before my session, choose to eat fruits and vegetables, or if possible, to limit food intake or do a light fast.
5. I understand that no food is allowed in the EES room.
6. I understand it is vitally important to be hydrated before my session, during my session and after my session. I understand I can bring water into the recharging area of the EES room.
7. I agree when entering the EES business location and EES room, I will do so with an attitude of positivity, unlimited potentiality, and sacred connection.

8. I agree to leave all negativity outside the doors of this business establishment.
9. I agree to come with clear intentions of what I want to achieve in the EES room, but I remain open to the needs that are prioritized by the body's wisdom.
10. I am open to spontaneous remissions/healings, but I also understand that longstanding illnesses may take additional time to heal.
11. I understand that the scalar energy vibration is very high, and this energy connects with my personal Higher Source energy to create a collaborative healing process.
12. I will enter the EES room using a soft, whispering voice so as not to disturb others' peace.
13. I agree to not bring any electronics into the EES room except for my cell phone, which must be placed on silent mode.
14. I will place my shoes directly outside the door of the EES room and will reclaim them when my session(s) are over.
15. If I choose, inside the EES room, I will place my personal belongings in a basket in the cubbies or I can place the basket with my belongings next to me and my chair during my session.
16. If desired, I may place a special object or small photo of a loved one on the EES altar on the top of the cubbies.
17. I may also bring a jug of water to be hyper-charged in the Recharging Area.
18. I understand I can bring my own blanket and that it too, will be charged by the EES energy.
19. If/when I need to go to the restroom, I will leave quietly and return quietly so I don't disturb anyone's session.
20. If I want to listen to special music or guided meditations on my phone or Mp3 player, I will do so with ear buds, in a volume that is inaudible to others.
21. When 15-20 minutes are left remaining in my session, I will hear a chime which means it is time to begin awakening from my trance state.
22. I will begin to hear repetitive chimes when it is time to wake up and begin gathering my things.
23. An EES Attendant will enter the room 5-10 minutes before my session is over to make sure everyone is awake and preparing to leave the EES room. Those who are staying for the next session will stay seated.
24. I will gather up all my possessions in the basket, return the basket into the cubby bin and retrieve my shoes outside the EES room, before departing.
25. I understand that any object left behind will be placed in our Lost & Found and our staff will do our best to identify who the owner is, however, we are not responsible for misplaced items.
26. I understand that failure to detox following my session has been shown to be challenging to the mind and body and may contribute to sluggishness or fatigue the next day. Therefore, within 24 hours of my session, I agree to do a detoxing bath using my own mixture of sea salt, borax (or non-borax), baking soda, and essential oils or I will purchase a pre-mixture from EES Austin. (Do not use Epsom Salts as recommended by Dr. Michael)
27. I understand that the effects of the charged EES field are cumulative. The more I am exposed, the more my body can move toward a healthy millivolt level.
