

# Crafting BDSM tweets

Crafting tweets about BDSM fetishes like blackmail, financial domination, exposure, tech domination, homewrecking, and intoxication requires careful wording to stay within Twitter's (X's) Terms of Service (ToS) while still engaging your audience. The examples listed below have been tried and tested so using them will appear as if you have copied and pasted from my account, please avoid doing that.

As of 25th March 2025, X's rules prohibit content that promotes illegal activities, non-consensual acts, or graphic violence, and they have strict guidelines around adult content. However, they do allow discussions of adult themes if framed appropriately—typically requiring subtlety, avoiding explicit detail, and ensuring consent is implied or stated. Below, I'll provide guidance for each fetish, with context and examples, to help you navigate this balance.

## General Context

X's ToS (under "Sensitive Media" and "Abusive Behavior") flags content that's overly explicit, promotes harm, or targets individuals without consent. For BDSM-related tweets, the key is to:

- Use suggestive, abstract, or coded language instead of explicit descriptions.
- Emphasise fantasy, roleplay, or consensual dynamics to avoid implying real harm or illegality.
- Avoid direct calls to action that could be seen as soliciting illegal behavior (e.g., actual blackmail or financial exploitation).

# Fetishes

## 1. Blackmail

Context: Blackmail in BDSM is typically a consensual fantasy where a submissive gives a dominant "leverage" (e.g., compromising info) to simulate coercion. In reality, it's illegal and unethical without consent, so X could interpret literal blackmail references as violating their rules against harassment or illegal activity.

Guidance: Frame it as a power exchange or mind game, not a literal threat. Avoid specifics like "I'll expose your secrets" or real personal data. avoid using the literal term blackmail as this will likely flag your account.

Examples:

- "Surrendering control is the ultimate thrill—knowing I hold the keys to your little secrets."
- "A game of trust where the stakes feel oh-so-dangerous... but it's all in your head."
- "Teasing the edge of power—who needs reality when fantasy grips this tight?"

## 2. Financial Domination (Findom)

Context: Findom involves a submissive giving money or gifts to a dominant, often for humiliation or control. X allows this conceptually but cracks down on direct solicitation that mimics scams or violates their "Platform Manipulation" rules (e.g., spamming payment links).

Guidance: Focus on the psychological allure, not transactional details. Avoid begging for cash or posting payment links excessively—hint at the dynamic instead.

Examples:

- "Nothing says devotion like watching your wallet beg for my attention."
- "Power isn't free, pet—every tribute whispers your submission."
- "Some kneel with words, others with their worth—guess which I prefer?"

## 3. Exposure of the Submissive

Context: Exposure fetishes involve the risk (or fantasy) of public humiliation, like sharing a sub's identity or photos. X prohibits non-consensual nudity or doxxing, so this must stay hypothetical and vague to avoid bans.

Guidance: Keep it abstract and fantasy-driven. Never imply real exposure or share identifiable info, even as a tease. Under no circumstance should you post a subs media or personal info even with consent. If you are going to do this, use an exposure website or a backup account. I promise you, X will suspend your account, I know this oh so well... (I've been banned 6/7 times for this).

Examples:

- "The rush of \*almost\* being seen—your secret's safe, but your pulse isn't."

- “Imagine the world knowing your place... but only I hold that power.”
- “Teetering on the edge of shame—deliciously dangerous, yet all mine to control.”

## 4. Tech Domination

Context: Tech domination might include controlling a sub’s devices (e.g., via remote software) or imposing digital restrictions. X could flag this if it seems like promoting malware, hacking, or risky links, which violate their “Safety” policies.

Guidance: Focus on the control aspect, not technical specifics. Avoid linking to anything sketchy or suggesting actual device compromise.

Examples:

- “Your screen, my rules—locked down and loving it.”
- “Handing over the reins to your digital world... how deep will you go?”
- “A click, a command, and you’re mine—tech bends to my will.”

## 5. Homewrecking

Context: Homewrecking fantasies involve a dominant “ruining” a sub’s relationship, often for erotic thrill. X might see literal interpretations as targeting or harassing real people, which breaks their “Abuse” rules.

Guidance: Keep it a vague, fictional scenario. Avoid naming real partners or implying actual interference.

Examples:

- “Whispering chaos into your little life—what’s a vow against my voice?”
- “A fantasy so wicked, it unravels everything you thought you knew.”
- “Temptation’s pull—stronger than any promise, sweeter than regret.”

## 6. Intoxication

Context: Intoxication fetishes (e.g., poppers, alcohol) involve altered states for heightened submission. X bans content promoting drug use or excessive alcohol consumption under “Illegal Content,” so direct references are risky.

Guidance:

Use euphemisms or focus on the sensation, not the substance. Avoid instructing or glorifying use explicitly.

Examples:

- “A haze that drops you to your knees—lost in my command.”
- “Mind swimming, edges blurring—all for me, isn’t it?”
- “Drifting deeper with every breath—submission feels so light.”

## Broader Tips

- **Imply Consent:** Phrases like “willingly,” “by choice,” or “in our game” signal that this is consensual roleplay, distancing it from real harm.
- **Use Humor or Flair:** Lighthearted or dramatic tones (e.g., “pathetic little pets” or “bow to your queen”) keep it playful and less likely to be flagged.
- **Monitor Feedback:** If followers report or X removes a tweet, adjust your phrasing—X’s enforcement can be inconsistent.

## Why This Works

X’s algorithm and moderators prioritise user reports and blatant violations. Subtle, fantasy-driven language flies under the radar while still resonating with your audience. BDSM communities online often use coded terms (e.g., “tribute” for payment, “edge” for risk) to self-regulate and stay compliant. By adopting this approach, you align with both the platform’s boundaries and the subculture’s norms.
