

Parental Control Agreement

This Contract is between (the "submissive") and Madam Malevolent (the "Dominatrix").

The Contract is dated __/__/__.

1. CONTROL AND PAYMENT

1.1 Project

The submissive is requesting the Dominatrix to do the following: Control submissive's device for a __ month period with intentions to review and extend.

1.2 Schedule

The Dominatrix will begin control on __/__/__ and the control is ongoing. This Contract can be ended by either submissive or Dominatrix at any time, pursuant to the terms of Section [4. TERM AND TERMINATION](#).

1.3 Payment

The submissive will pay the Dominatrix a rate of £____ (GBP) per _____. Of this, the submissive will pay the Dominatrix £____ (GBP) before control begins. The Dominatrix is entitled to further fees from the submissive in relation to this project unless otherwise agreed. Fees can be for bad behaviour, late payments, not fulfilling tasks and anything else the Dominatrix wishes.

1.4 Invoices

The Dominatrix will invoice the submissive weekly. The submissive agrees to pay the amount owed within 1 day of receiving the invoice. The Dominatrix shall be entitled to charge, and the submissive shall pay interest on any unpaid amount from the due date until payment is received at a rate of __% per _____ on the outstanding amount.

2. CONTROL

2.1 Dominatrix Use Of Parental Control

Once the Dominatrix takes control of the submissive's device, the Dominatrix owns all rights to it, except those that the submissive and Dominatrix agree to. These will be attached to the contract via cover note by the submissive to ensure boundaries are respected.

3. NON-SOLICITATION

Until this Contract ends, the submissive will not:

- (a) serve any other dominatrices;
- (b) pay any other dominatrices;
- or (c) contact any other dominatrices.

The one exception is if the Dominatrix orders the submissive to conduct any of the aforementioned. In that case, the submissive may serve, pay or speak to another Dominatrix as ordered. The submissive promises that it won't do anything in this paragraph on behalf of itself.

4. TERM AND TERMINATION

4.1 Term and Termination

This Contract is ongoing, until ended by the submissive or the Dominatrix. Either party may end this Contract for any reason. The submissive must pay a buy out fee of £____ and send a message to the Dominatrix, informing the recipient that the sender is ending the Contract and that the Contract will end upon receipt of payment. The Contract officially ends once that payment has been received. [5.2](#) The Dominatrix must immediately stop working as soon as she receives payment, unless the notice says otherwise.

5. GENERAL

5.1 Modification; Waiver

To change anything in this Contract, the submissive and the Dominatrix must agree to that change in writing and sign a document showing their contract. Neither party can waive its rights under this Contract or release the other party from its obligations under this Contract, unless the waiving party acknowledges it is doing so in writing and signs a document that says so.

5.2 Notices

- (a) Over the course of this Contract, one party may need to send a notice to the other party. For the notice to be valid, it must be in writing.
- (b) The timing of when a notice is received can be very important. If a party refuses to accept notice, then it is considered received when the notice is rejected or unable to be delivered.
- (c) The buy out fee must be paid in full to the Dominatrix at the time the notice is given.

5.3 Third Party Rights

A person who is not a party to this contract shall not have any rights under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of this contract.

5.4 Signatures

The submissive and the Dominatrix must sign this document Online. These electronic signatures count as originals for all purposes.

5.5 Governing Law and Jurisdiction

The laws of England govern the rights and obligations of the Client and the Dominatrix (both contractual and non-contractual) under this Contract, without regard to conflict of law principles. The courts of England shall have exclusive jurisdiction in determining any dispute (whether contractual or non-contractual) under or in connection with this contract.

5.6 Entire Contract

This Contract represents the parties' final and complete understanding of control and the subject matter discussed in this Contract. This Contract supersedes all other contracts (both written and oral) between the parties. Nothing in this paragraph excludes either party's liability for fraud.
