This agreement must be entered voluntarily, but cannot be broken except under the conditions stated herein, after which certain precautions shall be taken to protect those involved"

The purpose of this contract

1. state the full mutual consent of the undersigned in regards to this relationship.
2. to clearly define the responsibilities and duties of both Mistress and sub.
3. Explain the use of punishment and clearly define what punishment is, safe words and Limits.
4. Duration and termination
I, hereinafter referred to as Slave, do of my own free will, and being of sound mind and
body, do hereby offer myself in consensual slavery to Madam Malevolent, hereinafter referred to
Mistress, for the period beginning at midnight on//

I. ROLE AND OBLIGATIONS OF THE SLAVE

- 1. To accept the claim of ownership over his physical body, mind and phone by Mistress. To become the property of the Mistress and that henceforth be commanded, trained and punished as a slave and be duty bound to fulfil the pleasures and desires of his Owner to the best of his abilities.
- 2. To submit himself to his Owner fully and completely. To accept any training, punishment, humiliation, degradation or other use demanded of him by his Owner.
- 3. The slave gives the Mistress the sole and exclusive use of his body. This may include, but is not limited to shaving of his body hair, body weight and manner of dress and undress. The Owner may order any modification to the body of the slave as she sees fit. The slave will not enter into any other agreement with any other person for the use of his body to include sexual relations without first obtaining permission from his Owner.
- 4. The slave must make himself available to his Owner at all times.5. The Slave will greet Mistress daily and thank her for ownership via ______.
- 6. If for any reason the slave learns that he may be unable to respond immediately to an order from his Owner, he must immediately seek the permission of his Owner.

7.The Owner may at any time, give, rent, lend or sell the slave to another Mistress without consulting or giving notice to the slave. The rights and privileges afforded by this contract will be automatically transferred to the new Owner.

- 8. The Owner shall have complete and absolute control over the slave, (that means body, mind and phone) and all of her commands shall be swiftly and diligently obeyed. The slave will accept any and all consequences for failure to do so.
- 9. The slave may ask for this contract to be amended or terminated with no less than 1 month notice.
- 10. The Slave is to make regular financial weekly payments to the Mistress via _____ method. Late payments will result in punishment.
- 11. The slave is to inform the Mistress of any and all implements in possession of the slave that can be used for training and punishment of the slave.
- 13. The slave is to achieve orgasm only by express self permission of the Mistress. I understand that a submissive's orgasms are controlled for proper training and will allow me this reward when She desires.

II. ROLE AND OBLIGATIONS OF THE MISTRESS

The Mistress will have ownership of the slave's body and life, to use and or abuse as She sees fit for whatever purposes She desires.

III. Punishments

IV. DURATION

- 1. If the Owner is unable or unwilling to keep the services of the slave, this contract may be either terminated by Her without notice at any time or transferred to another Mistress.
- 2. Upon termination of this contract and completion, arrangements will be made for the removal of control of the slave..
- 3. If the slave attempts to break this contract (i.e. by stopping compliance with any of its terms or by refusing to accept the Mistress domination of him), the slave shall be Dismissed from service and unable to serve again until a _____ fine is paid. Or She deems necessary to enforce compliance, including but not limited humiliation of the slave by publicly naming him and/or releasing incriminating photographs of him.

I have read and fully understand this contract in its entirety and I agree to henceforth adhere to and be bound by all of the rules and clauses contained herein, henceforth to relinquish my rights to self-determination and free will until such time as the contract is terminated by the Owner or by

myself. I understand that I face exceptionally harsh physical and emotional punishment for failing to fulfil any clause within this contract.
