



# Blackmail Contract

Madam Malevolent

## Parties

This blackmail agreement made between the Dominant, Madam Malevolent and the slave, \_\_\_\_\_ entered into on xx/xx/xx.

## Terms

## Clauses

If I renege on any part of this contract, Madam Malevolent has my permission to contact family, friends and twitter to reveal all the details (including but not limited to photos and video) Madam Malevolent has procured by any means whether voluntarily offered by me or procured in any other way.

This contract will last for no more than three calendar months unless otherwise agreed by Madam Malevolent and the slave, the slave \_\_\_\_\_ will have no say. It will start on xx/xx/xx.

If I want to terminate this contract at any time I will pay Madam Malevolent the sum of no less than £1,000. After payment, the slave, \_\_\_\_\_ will be released from Madam Malevolent blackmail terms of contract unless she states otherwise and the slave, \_\_\_\_\_ will have no say.

If I fail in any task, at any time during the aforementioned period, Madam Malevolent has my permission to send the information I have provided here and the photos\* I have sent to her as well as any photographs or information Madam Malevolent has procured throughout the duration that this contract is in effect to my family, friends and twitter or any other site Madam Malevolent seems suitable, even if the time period stipulated in this contract has elapsed.



Payment will be made in any way deemed appropriate by Madam Malevolent including but not limited to fan sites, gift cards, bank transfer or through other sites Madam Malevolent deems suitable.

All transactions will be recorded by Madam Malevolent and may be recorded by the slave, the slave \_\_\_\_\_, for the protection of both parties.

If this clause in the contract is broken by the slave, \_\_\_\_\_, Madam Malevolent has my permission to send any or all details of the contract, including but not limited to photos and videos consensually sent to Madam Malevolent by the slave, \_\_\_\_\_.*

3. A photograph of the slave, the slave \_\_\_\_\_ wearing panties, again face must be fully visible.
