Terms & Conditions

Please review the below terms and conditions and sign below.

Payment Policy – A non-refundable registration and/or materials fee, along with the session fee for the current month, is due at the time of registration and must be paid before the first session. After that, monthly payments are due by the 5th of each month. A \$15 late fee will be applied to any payment not received by the due date. For group packages, payment is due before the first session, and renewal payments are due one week prior to the start of the next session.

Cancellation Policy – A written cancellation notice must be submitted at least 14 days prior to the next billing cycle to withdraw from a Frommis Inc. Spanish program. No refunds or credits are provided for missed classes. If you cancel with at least 24 hours' notice, you may schedule one make-up group session per month, subject to space and availability. No-shows or cancellations made with less than 24 hours' notice are not eligible for a make-up session. Spanish camp fees are non-refundable.

Behavior Policy – Frommis Inc. reserves the right to deny entrance and/or continuation of any program to any person or student who is unruly or does not respect the rules of the Frommis sessions. No refund will be provided in such cases.

Restroom Policy – Frommis Inc.'s premises have communal restrooms, and each student is expected to use the restroom before or after their session to avoid interrupting session time. If the student needs to use the restroom during the session, an instructor will provide directions to the restroom.
