Code of Conduct

Acknowledgment & Release

- a. Players agree to conduct themselves in a responsible manner and to indemnify and hold harmless the Edison Ice Hockey Club, its Directors, Officers, Board Members, Coaches, Managers, other Members, and Agents from any and all claims, losses, and damages which may be suffered or incurred. **Edison Ice Hockey Club is independent, and not a part of, the Huntington Beach Union High School District, Edison High School, or its Administrators.**
- b. Players agree to provide their **USA Hockey Membership** number for the CURRENT season, prior to participating in clinics or tryouts. USA Hockey Registration can be found at <https://usahockeyregistration.com>. The club must receive confirmation of the player's USA Hockey registration prior to any participation with the Club.
- c. Players agree to abide by all regulations as set forth by Edison Ice Hockey Club, ADHSHL, CAHA, and USA Hockey, their guidelines and rules, by-laws, and disciplinary proceedings administered by the ADHSHL Board of Directors Disciplinary Committee.
- d. Tryout registration fees are non-refundable
- e. Any dispute arising out of or relating to participation in the ADHSHL, Edison Ice Hockey Club shall be resolved through binding arbitration administered through an arbitration provider in the County of Orange, State of California, and judgment on the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof. Each side shall equally bear the expense of arbitration unless otherwise agreed upon. The arbitration proceeding shall be governed by California Code of Civil Procedure §1280 et seq. in effect at the time of arbitration, or any other rules the parties mutually agreed upon in writing.
- f. **DRUGS, ALCOHOL & VAPING:** There will be a zero tolerance for any type of illegal drugs, alcohol, tobacco and vaping of any kind during any club activities. If a player arrives to a club function in possession of or suspected of being under the influence of any of these referenced items, they will be immediately suspended from the program pending a disciplinary meeting, with no chance of a refund.
- g. **LOCKER ROOM, ON-ICE, & OFF-ICE CONDUCT:** All players are expected to respect their teammates and their property. Verbal abuse, bullying, or fighting will not be tolerated. The Club follows USA Hockey's "SafeSport" policies and is strictly enforced at all games and practices. The Club and its Members represent Edison High School at said activities and as such, any misconduct may be reported to Edison High School, whom at its own discretion may discipline members as it sees fit.
- h. **SOCIAL MEDIA & TEAM COMMUNICATION:** The club will strictly adhere to the USA Hockey cell phone locker room rule. **Cell phones are NOT allowed and NO photos or videos may be taken inside any locker room under any circumstances.** Any negative communication about the Edison Ice Hockey program, officials, the ADHSHL, a teammate, another player/team or coaches via any social media or other means of digital communication (Facebook, Twitter, Instagram, SnapChat, group text, messaging platforms, etc.) is unacceptable and punishment may include loss of playing time, suspension or a release from the club depending on the severity of the incident and at the discretion of the board, coaches and high school administration.

- i. **CONTENT & LOGO OWNERSHIP:** All content, text, graphics, logos, button icons, images, audio clips, video clips, digital downloads, data compilations and software are the property of the Club, and may not be reproduced, duplicated, copied, sold, resold, visited or exploited for any commercial purpose without the express written consent of the Club. Any websites or other social media content created to represent this Club must be pre-authorized by the Club.
- j. **COVID-19 & PANDEMIC PROTOCOLS:** In the event of a public health emergency declared, players and guests agree to abide by all current COVID-19 & Pandemic protocols, including but not limited to: Face coverings, social distancing, testing, health declarations, spectator limitations, etc. Players and guests may be excluded from participating based on current CDC, state, local, ADHSHL, CAHA, SCAHA, and facility guidelines. Refunds will not be issued for events missed due to COVID-19 & Pandemic exclusions.
