By signing this agreement I acknowledge and accept the following terms:

I have been given the full opportunity to ask any and all questions and about obtaining a tattoo or relating to tattoo services. I have communicated my questions and concerns pertaining to my specific tattoo inquiries and I have been given all answers to my full satisfaction. I agree to the following:

- ☐ 1. If I have any condition that may affect the healing of this tattoo (diabetes, cardiopulmonary and oxygen transport conditions, immune deficiencies, etc.) I will advise my tattoo artist. I do not have any mental impairments that may affect my judgment in getting the tattoo.
- ☐ 2. I am not pregnant, nor am I nursing. I am not under the influence of drugs or alcohol.
- ☐ 3. If I have any type of infection or rash ANYWHERE on my body, I will inform my tattoo artist. I do not have any medical or skin conditions such as but not limited to: eczema, psoriasis, moles or sunburn of which may interfere with the area I am getting tattooed.
- ☐ 4. I acknowledge that it is not reasonable possible for the representatives or artist of this tattoo shop to determine whether I might have an allergic reaction to the pigments or processes used in or during my tattoo. If I have knowledge of any allergies I WILL notify the artist. I agree to except the risk that such allergic reactions are possible.
- ☐ 5. I acknowledge that infection is always possible when obtaining a tattoo, particularly in the event that I do not take proper aftercare of my tattoo. I have received aftercare instructions and agree to follow them until my tattoo is fully healed. I agree to avoid submerging my tattoo in salt water, swimming pools and any and all rivers, lakes, etc. until my tattoo has fully healed, as such actions could introduce bacteria to my unhealed tattoo. I agree that any touch up or medical attention needed, due to my own negligence, will be done at my own expense.
- ☐ 6. The tattoo studio and artists are not responsible for the meaning or spelling of any symbols or text that I have provided to them or chosen from any flash or design sheets. I am solely responsible for all official spellings and meanings of my tattoo.
- ☐ 7. I understand that variations in color and design may exist between the tattoo artists I have selected and the actual tattoo when applied to my specific body. I understand that colors and the clarity of my tattoo can fade and change over time especially when prone to unprotected sun exposure and the naturally occurring disbursement of pigments within the skin
- ☐ 8. I understand that if I have had any skin treatments such as, but not limited to; laser hair removal, plastic surgery or other altering procedures, it may result in adverse changes to my tattoo.
- ☐ 9. I acknowledge that a tattoo is a permanent change to my appearance and that no representations have been made to me as to the ability to later change or remove this tattoo.
- ☐ 10. I acknowledge that I am over the age of 18 and have presented my artist and/or management with a valid and legal ID. I have truthfully represented to my tattoo artist that obtaining my tattoo is my choice and I consent to the application of this tattoo and to any and all necessary procedures in obtaining of this tattoo.
- ☐ 11. I have been fully informed of the inherent risks of receiving a tattoo and have fully read this contract. I wave and release to the fullest extent permitted by law, any persons of the tattoo studio from all liability whatsoever, including but not limited to; infection, scarring, difficulties in the detection of melanoma and allergic reactions. Having been informed of all risks, I wish to proceed with the tattoo procedure and freely accept responsibility for myself and all risks that may arise during and after my tattoo procedure.
