
# Swinger-75W Ver. 4 Setup Instructions



#### **Overview:**

Thank you for purchasing this from KRN Solutions LLC. This control is unique to what you may have used before, So I would recommend reading this setup instructions completely before going to any job site. The most current version and other supporting documents can be found at www.krnsolutionsllc.com.

This control is a microprocessor base control. This allows flexibility in functions for both current and future features. All adjustments can be made without a handheld/computer. It uses a 24 VDC regulated power supply. It can be used with panic bars using a motor activation such as Von Duprin QEL, Sargent, Detex panics, and 24VDC magnetic locks or strikes.

# Startup:

There is a 15 second delay on power up/fire alarm recovery. On power up/fire alarm recovery. All of the input LEDs and watchdog LED will be on. The input LEDs will go out one by one. When they are all out the Watchdog LED will start to blink. The control is now working.

## **Inputs:**

Each input has an LED to indicate input statues. Control also has a power and watchdog (WD) LEDs. This WD LED will blink indicating the control has power and the program is running.

Label	Function
FIRE DRY INPUT	Fire System Setup: Dry, normally closed contact from fire system. Set switch as shown.
FIRE 24VDC INPUT	Fire System Setup: 24VDC from fire system.  Note: When set for 24 VDC in, if polarity is wrong, control will work, but LED will not light. Set switch as shown.
T CLOCK Time Clock	Dry contact, that is to be normally open. When closed, removes/applies power to MAG/STRIKE output only. This will also enable the EXT. PP input. Usage: Day/Night on a door is used for both security and fire with positive latching.
INT. PP Interior Push Plate/Sensor	Dry contact, that is to be normally open. When closed, removes/applies power to MAG/STRIKE, applies power to PANIC 1, PANIC 2 outputs and close both ACTIVATION outputs. Usage: Card reader, inside push plate. Outside push plate, if it is to be active 24/7.
EXT. PP  Exterior Push Plate/Sensor	Dry contact, that is to be normally open. When closed, closes both <b>ACTIVATION</b> outputs.  ONLY if the <b>T CLOCK</b> or <b>CARD</b> inputs where activated first. <b>Usage:</b> Outside push plate that is to be disabled at night.
CARD Card Reader	Dry contact, that is to be normally open. When closed, removes/applies power to MAG/STRIKE, output, and applies power to PANIC 1 and PANIC 2 outputs. This will also enable the EXT. PP input. Usage: Day/Night on a non-fire rated door, Card reader.

# Outputs: Each output has an LED to indicate output statues.

Label	Function
+ MAG -	MAGNETIC LOCKS/STRIKE: Can be set for, fail safe or fail secure 24 VDC locks. See below for
	settings. Max 2 amp output.
+ P1 -	PANIC 1: This is 24 VDC for the first panic. Max 2 amp output.
+ P2 -	PANIC 2: This is 24 VDC for the second panic. Max 2 amp output.
ACT.1	<b>ACTIVATION 1:</b> Dry contact, that is normally open. Activation for primary automatic door control. Max 1 amp.
ACT.2	<b>ACTIVATION 2:</b> Dry contact, that is normally open. Activation of a secondary automatic door control or other device(s). Max 1 amp.
Z Q GIZ	<b>DOGGED PANICS:</b> Some doorways can be dogged/unlatched till there is a fire. This saves wear and tear on the panic(s) and reduces the noise during operation. Move switch 1 to <b>ON</b> to enable this function.
2 503 2 503	<b>Fail Safe/Fail Secure Setting.</b> This selects the type of lock connected to the <b>Mag/Strike</b> output. Set switch 2 to <b>OFF</b> for fail secure locks. Set to <b>ON</b> for fail safe locks.
+ 24 -	This is a constant 24VDC at 2 amps for power to delay egress magnetic locks. This is removed when the fire alarm input is deactive.
NC  Com NO	This is an SPDT relay contact that will change state with the <b>MAG/Strike</b> output. It is for release of delayed egress magnetic locks. Set switch 2 to <b>ON</b> for fail safe locks.

# **Fire System Output:**

This relay output is rated at 120VDC at 5 amps. Used to disable automatic door control(s).

NO = Normally Open

C= Common

NC = Normally. Closed

This is with the fire system in normal mode.





Label	Function
PANIC 2 ON	This is an on delay from MAG/STRIKE and PANIC 1 to PANIC 2 output. If only a strike/mag is
DELAY	used, set to min delay. This delay is adjustable from .25 to 2 seconds.
ACTIVATION	This is an on delay from <b>PANIC 2</b> to <b>ACTIVATION #1</b> output. This delay is adjustable from .25 to 2
ON DELAY #1	seconds.
ACTIVATION	This is an on delay from <b>PANIC 2</b> to <b>ACTIVATION #2</b> output. This delay is adjustable from .25 to 2
ON DELAY #2	seconds.
ACTIVATION	This is an off delay for the <b>ACTIVATION</b> outputs. This delay is adjustable from .25 to 10 seconds.
OFF DELAY	This is also the amount of time the <b>EXT. PP</b> input is active.
LOCK OFF	This is the time the MAG/STRIKE, PANIC 1 and PANIC 2 outputs will hold active. It is a
DELAY	combination of both ACT. OFF DELAY and LOCK OFF DELAY settings. This delay is adjustable
	from .25 to 20 seconds.
STRIKE	This sets the Mag/Strike output voltage after 5 seconds. This will reduce the heat produced by
VOLTAGE	the strike. Leave fully clockwise for magnet locks.

#### **Basic Troubleshooting:**

Power	If the power supply shut down, check green power LED are light. Check that 115/220 switch is in
shuts off	the 115 position located on top of power supply. Check for shorts in wires and devices.
No input or	Check the WD LED is blinking. If it is not, check <b>Fire</b> Alarm input. Then remove power for 60
output	seconds. On power up, wait 60 seconds, if it still is not blinking. Replace lock control.

# **Mounting**

The plastic brackets, gives you two options to mount this control in a header or control box.

Using four #6 screws, mount control. Hand tighten only.

There is an optional no-drill mounting system for Horton, Record and Besam headers.



## Wiring of control inputs and outputs:

#### **120 VAC Wiring:**


- 1. For UL Installations, the power supply must be installed in the protected area within an Access Controlled room
- 2. Must be Installed within accordance with the National Electrical Code, ANSI/NFPA 70.
- 3. Must be Installed within accordance with Local authority having jurisdiction.
- 4. The AC input wiring shall
  - a. be in conduit,
  - b. be minimum No. 18 AWG wire,
  - c. maintain ¼ inch spacing between non power-limited wiring, and
  - d. be fail safe to meet the requirements of NFPA 101, Paragraph 7.2.1.6.

#### **Grounding:**


The ground wire from the power supply **MUST** be connected to chassis ground.


# 110 VAC Main




#### Handycap Door with Panics.




#### Handycap Door with Strike




#### Wiring for Delayed Egress Mag Lock






