They do not provide salting/de-icing services currently due to equipment being down. If we need the services, we call 360-204-3053 and a crew will be dispatched. Response time is undetermined.
- FLHA policy pre-approves up to \$500 expenditure for emergency snow removal.
- Carol and John McGhee will follow up with a couple of neighborhood members regarding the use of small lawn tractors and blades as a possible snow removal alternative.

New Business

- Entry Sign The sign at the entrance has deteriorated to the point where
 the sign and posts have rotted and the sign was falling over. It has been
 temporarily propped up with additional posts until a replacement option
 has been identified. Replacement can wait until spring. Elaine and Carol
 will research sign companies and determine options for consideration at
 the FLHA Annual meeting on May 20.
- Road Maintenance John Dashiell reported that the road asphalt where
 it meets his driveway was not sealed at the joint and the asphalt is coming
 up. John McGhee said that the road is due to be sealed soon and this
 could be included in the preparation/repair stage. Road sealing will be an
 agenda item at the FLHA Annual meeting on May 20.
