## Secretary's Report:

#### **Old Business:**

#### Road Maintenance/Tree Roots:

There were several locations along the road where tree roots were causing the road to buckle. They were removed, followed by the sealing of the road.

### **Beach Access Gate:**

The beach access gate continues to progress but had delays primarily due to either weather or coordinating the scheduling with the contractor. The next line item for the project is the "knox box" for medical emergencies, etc. Carol also has a remote that can be temporarily borrowed if you'd like to program the opener into your vehicle.

#### **New Business:**

## **Leaning Trees/Overhanging Branches:**

All homeowners are respectfully requested to walk your property in search of low hanging branches or leaning trees that encroach onto Landing Lane. High profile vehicles are being scratched, walkers are forced to work their way through the foliage when larger vehicles are on approach and potential broken branches or fallen trees pose a hazard in general. If you identify any trees that should be removed, please submit an ACC Application with the flagged tree(s) to remedy any potential hazard you may have. Furthermore, a letter will be going out to any homeowners by our next quarterly meeting if the ACC deems there are still risk potentials along Landing Lane.

If you are interested in having an arborist review your property, please let Elaine Herrera know and she will coordinate a day for them to review any properties.

### **Beach Easement:**

1) Does anyone own the seemingly abandoned boat down on the beach? Unless the boat is claimed, the new owner of that property has expressed interest in removing it.

2) The new owner's son, has started clearing and grading various areas of this property. We believe a Geotech has recently analyzed the property, but as of this meeting, no report has been shared with the FLHA. There has also been minimal to no ACC applications submitted for the extensive work he has already completed. There is concern and debate over the potential erosion and landslide potential in this area that would affect the road. Discussion is ongoing and has been difficult at times for all parties involved. Thank you to those who spoke on this subject and provided some insights and knowledge at the meeting. We all would like the new owner to be successful in their project, but the concerns for the road are many and the Board is seeking counsel. A motion was approved for funds towards that cause. As a reminder to all, the FLHA is responsible for the maintenance, repair and preservation of the road.

## **Election of one FLHA Board Director Member:**

Dennis Duff was reelected as FLHA Board Directors for a 2 year term expiring 2027.
