

a is a nucleus of helium $\binom{2}{4}$ and β is an electron (e⁻ for β^- and e⁺ for β^+). In every adecay, there is a loss of 2 protons and 4 neutrons. In every β^+ -decay, there is a loss of 1 proton and a neutrino is emitted from the nucleus. In every β^- -decay, there is a gain of 1 proton and an antineutrino is emitted from the nucleus.

Question 13.7:

A radioactive isotope has a half-life of T years. How long will it take the activity to reduce to a) 3.125%, b) 1% of its original value?

Answer

Half-life of the radioactive isotope = T years

Original amount of the radioactive isotope = N_0

(a) After decay, the amount of the radioactive isotope = N

It is given that only 3.125% of N_0 remains after decay. Hence, we can write:

$$\frac{N}{N_0} = 3.125\% = \frac{3.125}{100} = \frac{1}{32}$$

Question 13.8:

The normal activity of living carbon-containing matter is found to be about 15 decays per minute for every gram of carbon. This activity arises from the small proportion of radioactive ${}^{^{14}{\rm C}}_{6}{\rm present}$ with the stable carbon isotope ${}^{^{12}{\rm C}}_{6}$. When the organism is dead, its interaction with the atmosphere (which maintains the above equilibrium activity) ceases and its activity begins to drop. From the known half-life (5730 years) of $^{^{14}\mathrm{C}}$, and the measured activity, the age of the specimen can be approximately estimated. This is the principle of $^{^{14}\mathrm{C}}$ dating used in archaeology. Suppose a specimen from Mohenjodaro .poximat. gives an activity of 9 decays per minute per gram of carbon. Estimate the approximate age of the Indus-Valley civilisation.

Answer

Let N be the number of radioactive atoms present in a normal carbon- containing matter.
