This summer has given me the opportunity to read our constitution and by-laws, communicate with board members one-on-one, and collaborate with KRTA Executive Director Greg Roush. The Constitution of the JCRTA states the mission of JCRTA is to "advance the interests and welfare of retired teachers in Jefferson County and to assist retired teachers in maintaining identity with the teaching profession, support and promote the legislative agenda of KRTA, further the cause of public education through volunteerism and contributions and cooperate with the KRTA in securing desirable active representation on the Board of Trustees of the Teacher Retirement System." "Membership shall be open to any retired teacher or administrator formally employed in Kentucky." When I retired from JCPS several years ago, I was worried about what I would do with my new-found time. JCRTA filled my need and provided a huge network where I could stay in touch with educators around the state and JCPS. As I look towards the next two years, I am implementing three initiatives for JCRTA: 1. Increase JCRTA membership by 200 over 2 years; we currently have approximately 1,300 members., 3. Designate a local philanthropy in Jefferson County to support through volunteerism and contributions.

As your new 1st Vice President, I want to welcome you to another year of wonderful programming with JCRTA! I promise you we will do our best to provide you with programs that are engaging, enlightening, and entertaining!

Our next general meeting is on Friday, August 22, 2025. This meeting is also known as the KRTA Fall Workshop, and it is typically our most important meeting of the year. During this meeting, the leadership from KRTA (Kentucky Retired Teachers Association) and TRS (Teachers Retirement System) will give updates on pension, health-care, and legislative issues. It's our chance to hear firsthand about how these issues impact retired teachers!

Additionally, time will be allotted for visiting with the numerous KRTA partners who provide services for retired teachers – many at a discounted price. Some the partners for 2025-26 include Rebecca Park – KRTA Legeline, Hank Hensley – KRTA Finance and Investment Information, United Healthcare, Anthem, Collett Tours and Travel, Heuser Hearing Institute, and KRTA Dental and Vision Plans.

At the August 22 meeting, we will also be collecting monetary donations for school supplies for Goldsmith Elementary. With over 660 students, Goldsmith is one of the most diverse elementary schools in our state. Over 50% are Multilingual Learners with more than 25 languages represented. 13.7% of the students participate in Exceptional Child Education classes. More than 80% of the students at Goldsmith are classified as economically disadvantaged. You can see why Goldsmith is a great school for us to provide additional support for purchasing basic school supplies and books for classroom libraries!

Principal Jessica Carter is extremely proud of her staff and students. She says of her school, “We are truly a living, breathing portrait of Louisville’s evolving identity; we grapple with economic hurdles and academic disparities, yet pulse with cultural richness, while making deliberate, hopeful strides to elevate every child.”

I hope everyone is enjoying their summer break with vacations, maybe trips to the pool and fun family gatherings! Time is flying though, and we will be looking at fall before you know it!

Just like the school calendar, the state legislature has a break during the summer as well. While the legislature will not officially be in session until January, 2026 committees will begin meeting this fall and our legislators will begin having office hours as well. So it's time to start thinking about making our priorities known to our legislators.

KRTA is actively working on our game plan for the next legislative session. While our legislative priorities have not changed for 2025, we need to be certain that our legislators know and understand those priorities, especially given that this is a biennial budget year and will determine the contributions we receive from the state for our pension and for our health insurance premiums. We have been very fortunate the last 10 years that both the pension and the health insurance premiums have been fully funded. We hope this will continue in the next budget.

2025 KRTA Legislative Priorities

1. Fully fund the Teacher Retirement System (TRS).
2. Maintain the defined benefit system currently in place for Kentucky's retired teachers current and future.
3. Fully fund the Teacher Retirement System Health Insurance Fund
4. Maintain the current TRS board structure.
5. Oppose any legislation that would result in higher prescription costs for Kentucky retired teachers.

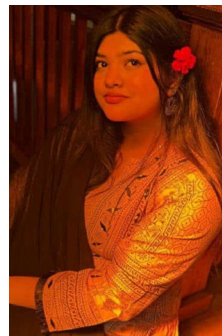

Later, she worked with the Smoketown Family Wellness Center's education lab, focusing on kindergarten students and their basic skills. As a high school student, she was an active participant in the Teaching and Learning Magnet Pathway where involvement with students exhibiting behavioral problems, mainstreamed special education students, and students exposed to trauma outlined the need for dedicated teachers in marginalized communities. KRTA Executive Council Meeting, June 2025

Outgoing President Rick Tatum presented the following **membership** information:

Potential Members = 44,391

KRTA Members = 31,692

Goal was 31,390

The KRTA Membership Committee meets in July to set a 2025-2026 goal.

The KRTA database has been updated and in order to safeguard them, KRTA will no longer use our TRS ID numbers. The new KRTA ID will consist of 12 digits comprised by the last four digits of your Social Security number and your eight digit birth date.

Margaret Sims, Outgoing **Health & Insurance** Committee Chair reminded us again about the Social Security Fairness Act which was signed into law on January 5, 2025. The act ended the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO), which for years has reduced or eliminated Social Security benefits for teachers. Margaret urged us to continue reminding our fellow teachers to check into their eligibility on a person by person basis because many people have not yet heard about the repeal of these provisions.

Out-of-pocket maximum for prescription drugs is now \$2000 due to the Inflation Reduction Act.

Allen Schuler, Legislative Committee co-chair explained that **HB 694**, which passed during the last legislative session, does not affect retirees. The original HB 540 "Shared Responsibility" was a collaboration between all stakeholders to solve Retired Teacher Health Insurance funding. The Health Insurance fund is almost 100% funded (projected 2027). HB 694 changes the language of HB 540 to continue requiring active teachers and school districts to continue paying their 3%. Teacher money would continue to go into the health insurance fund until further notice. District money would be re-directed to go toward the unfunded pension liability, attempting to pay it off sooner. All of us, active and retired groups, would prefer to see collaboration again as we did in 2010 to structure new language other than what is in HB 694.

Allen also reminded us of our success on the state level in defeating **Amendment 2** which would have allowed state budget money to be used for charter schools. However, currently on the federal level, the recently passed "Big Beautiful Bill" would set aside \$20 billion to encourage states to support charter schools.

2025 Teachers' Retirement System (TRS) Insurance

In the July 2025 KRTA News, **Margaret Head Sims, KRTA Chair Health and Insurance**, included information in her article that emphasis the importance of understanding our United Healthcare Plan. In 2023 our members received a letter from Baptist Health, stating that we could not use their facility and/or their doctors because our insurance did not include out of network healthcare. In May 2025, members received a similar letter from the University of Louisville. In her article Margaret Sims reminded us that our United Healthcare plan "does not have a network." The two questions to ask a provider are: do they "accept Medicare and will they file with United Healthcare." Medicare law does NOT allow a doctor or a hospital to discriminate. If the provider accepts Medicare from one patient, they must, by law accept Medicare from all patients. If you have not read Margaret Sims' article, I highly recommend it. It has much more valuable information about Social Security and insurance benefits. 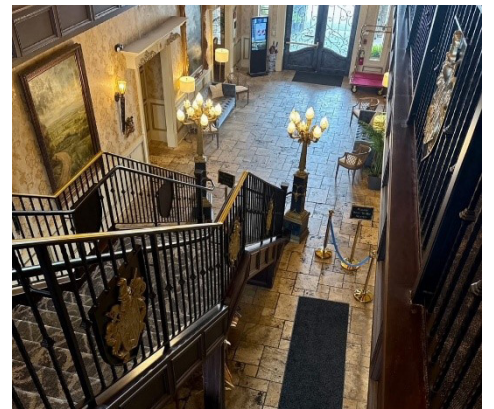


Day Trip 2025 - Kentucky Castle at Versailles
