The Jefferson County Retired Teachers Association is our local chapter of KRTA. JCRTA has two types of membership, which is regular membership and associate membership. Regular membership is made up of retired teachers who live in Jefferson County and receive their annuity check from TRS. They all live in Jefferson County and taught in Kentucky. Also, made up of retired teachers who taught in Jefferson County and receive their annuity check from TRS but do not live in Jefferson County. Associate membership is made up of people who do not receive an annuity check from TRS but are interested in the concerns of educators.

Some teacher's are confused between JCRTA and JCTA the teacher's union which has continuous membership for their teacher members. The membership for JCRTA is not continuous! The membership for JCRTA must be renewed each year. Our fiscal year is from July 1st to June 30th. The cost is \$15.00 a year! With this newsletter, you will receive a membership form to renew your membership. Please, return this membership form. When you renew your membership for 2024-25, you can either send in a check as usual or you can join by using our Credit Card Payment option. If you go to our JCRTA website (www.jcrta.org) you'll see an option on the Home Page to pay for membership by credit card. Follow the instructions to make a membership payment. We pay a .67 cent fee for this service; therefore, your credit card would be charged \$15.67. The fee is approximately the cost of a stamp so the

credit card option doesn't cost much more and may be more convenient.

KEHP (under 65 retirees)

Remember to complete the LivingWell Promise by the July 1 deadline.

• Retirees insured through the KEHP can earn up to \$480 a year (\$40) per month) in premium discounts in 2025 by completing an online health assessment by the deadline. It asks various health and lifestyle questions, and only takes about 10 minutes to complete.

- As of January 1, the LivingWell program is administered by Castlight, which is a change from WebMD.
 Registration is required if you have not created a Castlight account.

MEHP (over 65 retirees)

- VISA Gift Card \$50 reward for HouseCalls an inhome assessment program.
- Renew Rewards Gift Cards: reloadable, funds loaded within 24 hours of completed activity, consolidated rewards on one card for larger purchases, can see reward card balance and transaction details every time you log-in to Renew Rewards, must be used within 12 months, Annual Wellness Visit Rewards is now \$25.

REMEMBER to say NO! Enrolling in another Medicare Advantage plan will **cost you more money** and will automatically "TERMINATE" your TRS MEHP coverage. You may not be able to re-enroll.

Legislative Report

Spring is a wonderful time of the year in Louisville. The weather is warmer, the days are longer and the flowers are blooming! Let's not forget that Derby is just around the corner too! I hope you are enjoying the season with your family.

We have some good news to report from the state legislature this session. Last Friday was the 58th day of the General Assembly. They are off the first week of April but will gavel back in Monday, April 15th. Those days will see additional bills passed as well as possible overrides of the Governor's vetoes. Two of our priorities were realized last Friday. The Conference Report on House Bill 6 passed both chambers and how awaits the Governor's signature. It fully funds the TRS pension request and fully funds retiree health insurance as stipulated by the Shared Responsibility plan passed in 2010. This ensures that TRS will have been fully funded by the

General Assembly for 10 consecutive years!

There was a change to the proposal to pay off the unfunded liability. This is the liability caused by past administrations not paying into our pension plan. The original bill included a 500 million dollar payment. That was paired back to 80 million dollars.

KRTA followed several prescription drug bills throughout the session. KRTA advocacy was able to get an exception to allow TRS annuitants 65 and older and their dependents excluded from SB188. This means that our prescription drug plan will remain the same.

We appreciate the leadership of Tim Abrams, Greg Roush and the legislative team volunteers who have advocated for our interests in Frankfort. 2024 has been a good year for Kentucky's retired teachers!
