Where have the last 3 months gone? Have the days gone by quickly or slowly? For me, they have gone by like lightning. It could be because I don't get up early. I look over at Ralph and say, "Weren't we just here a minute ago?" I remember as a child when I used to complain about time going too slowly and my grandmother and others would say, "Don't try to grow up too soon." Or "Just wait, there will come a time when time will go so fast, you won't be able to keep up." Well folks, I'm there.

I found myself thinking about my grandmother who I called, Granny. She lived on a farm in Woodford County as a share-cropper most of my childhood.
