KRTA Representative Report

The last meeting of the KRTA Executive Council was held June 7, 2021 at the KRTA office. The meeting also included a "hybrid" component so that members who could not attend in person could participate VIRTUALLY in the meeting.

Sue Ellen Caldwell chaired the meeting completing her year as service as President of KRTA. Bill Kelley is the new President of KRTA.

The Membership/Pre-Retirement committee co-chairs urged all retired educators in Kentucky to reach out to those we know who are not members of KRTA and encourage them to join our ranks. They encouraged the development of a close link between our retired organizations and the local Boards of Education. This should assist us in gaining more timely access to the names of those educators who will be retiring in our areas.

The membership goal for KRTA for 2021-22 is 32,822. The Membership Committee reminded us of four options that retirees have to join KRTA. Those options are: 1. Mail in the cash form with a \$20.00 check addressed to KRTA; 2. Complete an Automatic Dues Deduction card and return it to KRTA; 3. (NEW) Use the KRTA Website to Join On-Line; 4. You can pay by phone by calling the KRTA Office.

Health and Insurance Committee Members encouraged us to have our members take advantage of the health connections available through TRS. This includes the services of Corielle, which does DNA testing to insure that the medications that your doctor is prescribing for you is appropriate for you. The committee is also studying the long term care policies that are held by several of our members that have developed issues because of excessive rate increases. They will be providing more information about this issue on the KRTA Website.

AARP reported that the Grandparent Essay contest will resume this year and they hope all KRTA District organizations will participate.

All Districts were also encouraged to participate in the School Supplies Drive and the Food Drive this year, as well.

The Council also approved the financial reports, to include the proposed budget, for 2021-22.

RETIRED TEACHER ADVOCATES FOR TEACH KENTUCKY PROGRAM

We would like to invite you to consider working as a Retired Teacher Advocate (RTA) with Teach Kentucky this coming school year (2021-22). We are a program that works to recruit nationally from elite colleges and universities and bring vivacious, dedicated, smart new teachers to Louisville where they will be enrolled in the University of Louisville (K-12), Spalding University (Special Education), or Asbury University (English as a Second Language) alternative certification MAT program and teaching in JCPS and surrounding districts.

A Retired Teacher Advocate is paired with 1-3 of our new teachers for a full year (if needed) to help provide nurturing support. Often, RTAs and their new teachers work together to set up a classroom, talk about a challenging class or student, help them to gain access to learning materials and curriculum, and enjoy meals together. We think this is a fun and unique pairing and look forward to you building a relationship with a new teacher(s) as they begin to teach in elementary, middle, or high school.

The program is designed for you to visit a new teacher(s) 2-3 times outside of school before school starts to talk about curriculum, classroom setup, etc. In addition, the RTA will observe the new teacher 2-3 times after school starts to provide feedback on lesson presentations. If they are all set up with classroom support, these relationships often morph into a dinner, coffee, or mentoring support role. We provide RTAs with a stipend of \$250 per teacher to cover travel costs and your time. There will be a training session during the summer on the lesson observation framework and expectations of the position.

Legislative Update

The KRTA Legislative Committee remains committed to working with Kentucky legislators to ensure Kentucky's retired teachers receive our full pension benefits. Although in-person access to legislators continues to be limited due to the pandemic, retired teachers are encouraged to communicate through emails, texts, and phone calls to share the following KRTA/JCRTA legislative priorities for 2021-2022.

- 1. Restore funding to the Medical Trust Fund as required by HB540, the 2010 Shared Responsibility Law. The Medical Trust Fund covers health insurance for those retired teachers under age 65. It was not funded by the General Assembly this past year as promised in the 2010 law. TRS had to cover the insurance for those under 65 with other funds. Remind legislators to pay their part (10%) and fulfill their responsibility to retired teachers.
- **2.** The General Assembly must continue to fully fund TRS. There is currently a \$1 billion surplus in the state budget. Kentucky's retired teachers deserve to have TRS fully funded as promised.
- 3. The General Assembly must maintain the Defined Benefit System for current and future retired teachers. Defined benefit plans provide the best pension coverage when compared to other retirement systems.
- 4. Make no changes to the board of trustee structure of the Kentucky Teachers' Retirement System. TRS investments have outperformed other retirement systems nationwide and our board members include retired teachers. Changing the structure of the board would not be to our benefit. Retired teachers must advocate for TRS to continue managing our investments.
