KRTA Executive Council Meeting, December 4, 2023

Highlights of the meeting presented for informational purposes only:

- -Julia Meredith from Monroe Shine presented our annual independent auditors report for KRTA. Overall, expenses were similar to last year. Our net, assets and cash equivalent have increased slightly, which is a good thing for the organization.
- -Rhonda Caldwell, CEO of KASA(Kentucky Association of School Administrators) presented 17 recommendations from a year-long study by the Coalition to Sustain the Education Profession. The number one priority recommendation increases teacher compensation setting a statewide minimum starting salary of \$45,000 and a 10% increase for all other teachers over the next two bienniums. The Coalition was comprised of 150 business, community, and education leaders and included 30 teachers. Their goal is to seek statewide policy to ensure that the teaching profession is a coveted role in society today. Their findings included the top three reasons for teacher job dissatisfaction are pay, student behavior, and time allocation.
- -Our Kentucky teacher turnover rate averages 20.4% while nationwide the turnover rate is 3.8%. Their 17 minute documentary entitled "Crisis in the Bluegrass is available to view on YouTube. The top three priorities, for the Coalition are:
- -Increased Compensation for Teachers
- -Funding for the Kentucky New Educator Training(K-NET) plan
- -Create a Kentucky Educator Stabilization Fund
- -More detailed information is available at www.kasa.org.
- -The KRTA history has been updated by Bill Kelley, Past President, as well as Patsy Young, Past President, and Debby Murrell, Statewide Membership Chairperson. Prior to this update, the history had not been updated since 2002. This information is available on the KRTA website.
- -Dates have been set for the 2024 KRTA fall workshops. As usual, Jefferson County will kick off the workshops with our meeting on Friday, August 23 at 10 AM. Please mark your calendars and plan to attend.
- -The KRTA Annual Convention is scheduled to be held at the Holiday Inn Hurstbourne in Louisville on Monday, April 22 -Tuesday, April 23, 2024. Please mark your calendar and plan to attend. More information will be available as time gets closer.
- -The 2024 mileage reimbursement rate for travel for KRTA business, will again be based on the allowable federal rate once those rates are released.
- -It has been recommended by the KRTA Executive Committee that KRTA begin to promote trips through Colette Travel for KRTA members, their families and friends. Any commissions

earned by KRTA from the 2024 trip to Ireland in October, and from any future trips booked through Colette, will be deposited into the Bourgard Fund. Further information will be forthcoming.

-Betty Hester, longtime Co-Chair of the KRTA Membership Committee as well as former Assistant Executive Director for many years, has decided to retire her position with KRTA. Please let Betty know how much you appreciate all of her work over the years.

Legislative Report

I hope you had a wonderful holiday season with your family! Now, as we change our focus to 2024, it is important that we re-emphasize our legislative priorities.

Our 2024 KRTA Legislative Priorities

- 1.To fully fund the Teachers' Retirement System in accordance with the states pension statute.
- 2. Maintain the defined benefit system currently in place for Kentucky's retired, current, and future teachers.
- 3. Fully fund the statutorily required obligation to the TRS Medical Insurance Fund as required by the Shared Responsibility Law.
- 4. Maintain the current TRS board structures.
- 5. Oppose any legislation that would result in higher prescription costs for Kentucky's retired teachers.

As Tim Abrams noted in his video message posted to the KRTA website, January began the current session of the Kentucky Legislature. It is also the time that the state budget will be determined. It is very important that our state representatives support a budget that will allow for our pension and insurance fund contributions to continue as required by state statute. Our lobbyists and volunteers will be in Frankfort during this time and will be meeting with our representatives to emphasize our priorities and to ask for their support. We will ask for our members to continue to voice their support by contacting their representatives as well.

Let's continue to work together to support these priorities for retired teachers!
