# KRTA Executive Council Meeting, June 3, 2024

This report combines 2 sets of minutes from meetings that have taken place since our last newsletter was published.

Membership and Pre-Retirement Chair, Debby Murrell said that letters have gone out to cash members to encourage them to maintain their membership in KRTA. Letters have also been sent to all new retirees to encourage them to join. Debby mentioned that LifeLock and Legal Line are excellent Membership benefits to use in recruitment. Tim Abrams reminded everyone that the numbers for retirement this year will probably be the most that TRS has ever seen.

At the 4/22/24 meeting, it was voted to make Debby an Honorary Member of the KRTA Membership Committee since she is stepping down as Chairperson.

**Health & Insurance Chair**, Margaret Sims discussed our United Healthcare Medicare Advantage Plan for over 65 noting that we have a policy for both our medical needs and Express Scripts for our pharmaceutical needs. The Express Scripts contract expires this year and we need to get as many of our retirees as possible to sign up for Express Scripts so we can continue to justify its existence. There was some discussion about Express Scripts and how it can help our retirees financially.

At the 4/22/24 meeting, Margaret emphasized the importance of saying "NO" to other Medicare plans advertised by celebrities on television.

Legislative Co-chair Larry Woods, discussed the Herald Leader report that revenue is an issue and it will probably be a struggle to try to get income tax to zero. TRS as well as most other state government agencies depend on that revenue. Larry discussed the School Choice Bill and how to ensure that our retirees are well informed about its potential impact on public education before they vote on the bill. Tim Abrams said that we are going to have a guest speaker from "Protect Our Schools" in August to discuss this bill.

At the 4/22/24 meeting, we were informed that our 2024 Legislative Priorities were successfully accomplished during the last Legislative Session. A draft copy of the KRTA 2025 Legislative Priorities were voted on and approved by the Executive Council. Further discussion included the importance of voting for TRS board members when we receive our ballots from TRS. Our participation will emphasize to legislators and others that we value the importance of keeping our TRS Board structure as it is.

**AARP/KRTA Specialist**, Cebert Gilbert, Jr. reminded Local Associations to take pictures as they participate in Food Drives and school Supply Drives this Fall. Tim asked for those pictures to be sent electronically, if possible.

It is important to KRTA and AARP to have these connections.

AARP can present programs for KRTA local meetings. Programs include Fraud Watch, Veterans Issues, Voter Turnout, etc. This will be Cebert's last year representing AARP on the KRTA Executive Council.

## **Executive Director's Report**

### **Treasurer's Report**

2024-25 Tentative Budget:

Investments are doing well, but we never want to spend more than we have coming in. Our revenue is based on dues from 31,000 members, a few sponsors, AARP, and conference registration. In earlier discussions, Greg mentioned that we only receive about \$9,000 in conference registration fees and usually spend about \$35,000. In a discussion on strategies to balance the budget, suggestions were made such as opting out of receiving printed paper documents, asking corporate partners to pay for ads in the KRTA newspaper, and using revenue from our Collette Travel partnership. Tim will send out suggestions to our committee members prior to the next meeting.

### New KRTA Investment Policy

At the 4/22/24 meeting, changes were made to the administration of the Bourgard Committee. In the future, the KRTA Executive Committee, consisting of President, Vice-President, President Elect and Past President, will serve on the committee and be responsible for making changes and recommendations as needed.

The Executive Council went into executive session to discuss the Executive Director's evaluation. President Gillespie reported that the evaluation comments were all positive, no negatives. Tim returned to the group and thanked them. He said that he has enjoyed working for and with KRTA. (At the 4/22/24 meeting, Tim had announced that he is stepping down from the position of KRTA Executive Director effective January 1, 2025.)

# Other Business/Remarks by Outgoing President:

Steve distributed a statement of thanks to the group.

There was discussion about the application process for the Executive Director position. Tim's last day will be December 31, 2024. The timeline includes:

- Hold Interviews in July, 2024
- Vote on approval of new Executive Director at the August Executive Council meeting
- August 1, 2024 start date for new director in order to have time to co-lead with Mr. Abrams.

The Council formally recognized and thanked Steve Gillespie, our outgoing KRTA president, for a job well done.

# **Legislative Report**

I hope you have been enjoying the summer months and this relaxing time with your family! Hard to believe that we're already half way through July! One thing that I've learned since I retired is that time really does seem to fly faster!

So... since fall with be here before we know it, we need to think about our goals and priorities for the next legislative session. While we did have a good legislative session this year with our main priorities of our pension and insurance need being fully funded, we still need to remain vigilant in continuing to get our 2025 priorities in front of our legislators. Our priorities for 2025 reflect our previous priorities.

## 2025 KRTA Legislative Priorities

1. Fully fund the Teachers' Retirement System in accordance with the state's pension-contribution statute. (KRS 161.500)

2. Maintain the defined benefit system currently in place for Kentucky's retired, current and future teachers.

3. Fully fund the statutorily required obligation to the TRS Medical Insurance Fund as required by HB540, the 2010 Shared Responsibility Law (KRS 161.550 and 161.420)

4. Maintain the current TRS board structure

5. Oppose any legislation that would result in higher prescription costs for Kentucky's retired teachers.

It is important that we continue to voice our support and concerns to our legislators in Frankfort. You can easily contact your representative by email by going to the KRTA website and clicking on the legislative tab. While the legislative session does not begin until January of 2025, committees will be meeting in the fall which is a good time to make our voices heard! Let's keep working together on behalf of all of us!

Representatives from United Healthcare, KRTA, and TRS have invited us to participate in boxing up and distributing teacher supplies for Jefferson County elementary teachers. 
