

A simple trip to the grocery store this week brought to my remembrance of the family gatherings of my youth when my Granny, Amanda Mae Newby, was still living. She was the master cook in the family. There were certain dishes she would always have at our Thanksgiving, Christmas or New Year's Day meals. One such dish was the Watergate salad. That salad was a mystery to me. I didn't know what went in it, but all I did know was that it was delicious. It was light green in color, shaped in a Bundt mold and the only ingredient I could identify was the marshmallows. I always associated that salad with special occasions and family. I didn't know the real name of the salad since Granny always called it Jell-O. It wasn't until I was grown, married with children of my own that I researched what actually was in it. As a small child, I had never eaten a pistachio nut before so it was understandable that I wouldn't be able to identify the taste. (For those of you who are interested, it is made with pistachio instant pudding, crushed pineapple, pineapple juice, marshmallows, and cool whip. --crushed pecans are optional.) . I hadn't made it myself for many, many years. Not since my grown children were small... so I didn't really remember much about it.

As aforementioned, while at the grocery store on Sunday, I saw a container of pistachio flavored ice-cream in the freezer section. It was not what pistachio tasted like that drew me to the container, but it was the color on the container that triggered something familiar. It was that same light green color. I decided I wanted to try it. My husband warned me if I didn't like it, the ice-cream might sit in our freeze and go to waste. He evidently wasn't sure about the taste either. So I put it back on the freezer shelf. We continued to talk more about the icecream, having traveled down several aisles, before we concluded that we would go back and get it.

After dinner that evening I announced I was ready for dessert. The pistachio ice-cream was served. After **one**

bite, all of the memories of yesteryear immediately came flooding back to me. New Year's Day dinner at Granny's house...The mysterious Watergate salad...it was oh so delicious! I was elated to discover that the ice-cream tasted just like that salad! Images of my grandmother's house, her dining room table where the older adults ate, and the enclosed side porch with a long table set up for the young people to sit. There would be so many people in the house we would have to take turns in shifts to eat. I could see all of the bowls and platters of casseroles, colorful vegetables and an assortment of meats in her kitchen on the table, stove and counters. It all came rushing back to me in **one** glorious SPOONFUL. It tasted like home! It tasted like heaven! That wonderful flavor that was reserved for special occasions made that Sunday afternoon for me, something special.

It wasn't until after we finished our dessert that I explained to my husband why this flavor meant so much to me. He said, "You should have lead with that story, now I understand why you had to have it." I didn't know it was going to taste like that but I'm sure glad to have had that sensory trip down memory lane. It's a wonderful thing to be able to remember. I hope you all will be able to create wonderful new memories as our family and friends begin to gather in person for holidays, birthdays and special events. KRTA Representative Report

The last meeting of the KRTA EXECUTIVE COUNCIL was held August 23, 2021. The items listed below are some of the current items that were discussed at that meeting.

We reviewed the current status of our financial investments for the organization. KRTA has two accounts: They are the KRTA Reserve Funds and the N.O. Kimbler-Bourgard Foundation Fund. Each accounts includes: 1. Cash/CDs/Guaranteed Investments; 2. Bonds/Bond Funds/Fixed Income/Equity Income Funds and 3. Equity/Equity Funds. The organization maintains two years of operating cash that is available. The annual audit revealed good management of KRTA funds and continued growth of the funds.

We discussed the membership goal for 2021-22 is 32,822 and we had 31,574 members as of the date of the Executive Council meeting. The Membership Committee continued to stress personal contacts of retirees.

Items mentioned by the Health and Insurance Committee are that 90 million people in our country are not vaccinated and encouraged all retirees to make sure that they are not one of the people in this category.

United HealthCare has extended the deadline for getting your gift card for your annual Wellness Visit until December 30, 2021. Renew Rewards number is 1-888-219-4602.

A couple items from the Legislative Committee were that: 1. The Census, that was just concluded, can redraw legislative districts in Kentucky and 2. Don Hines is stepping down as Legislative Co-Chair. Allan Schuler and Marshall Ward will be serving as Legislative Cochairs with Larry Woods.

Some dates that Local and District organizations need to keep in mind for the Grandparent Essay Contest are: Dates for submission of the Grandparent Essays; December 15th – School winner; March 1st - District Winner.

Upcoming Staffing Changes at KRTA Headquarters: Deputy Executive Director Janie Caslowe will be retiring effective December 31, 2021. Assistant Office Manager Charlotte Lindley will be retiring effective June 30, 2022. The KRTA Executive Council voted to establish a new KRTA Volunteer Leadership Position. That person would oversee several KRTA Volunteer programs such as the Volunteer of the Year Award and the Cathy Gullett Service Award. The volunteer selected for this position will work with the District organizations in publicizing these events.

Insurance Update

2022 Teachers' Retirement System (TRS) Insurance

Jane Gilbert is the Director of Retiree Health Care for TRS. (jane.gilbert@trs.ky.gov)

TRS (800-618-1687, 502-848-8500) offers two health plans for retirees:

- MEHP (Medicare Eligible Health Plan) Medicare-eligible or 65 & over, TRS members, one plan
- **KEHP** (Kentucky Employees' Health Plan) under 65 and not Medicare eligible, same fund as active teachers and state employees

MEHP Medicare Eligible Health Plan 2022 (Age 65 and over)

- Currently, Medicare Part B is \$148.50. We will not know until late November if there is an increase. Members pay Part B to Social Security.
- Premiums for spouses will increase from \$178 to \$211.
- Yearly (remains the same): Low deductible (\$150); Low out of pocket (\$1,200)
- No change: Emergency Room copayment (\$120); Urgent Care copayments (\$25)

MEHP Medicare Advantage Plan continues with medical provider United Health Care through 2022.

• <u>No Re-enrollment for 2022</u> for those currently participating in the KTRS MEHP. Members are automatically enrolled January 1, 2022 unless the member needs to make changes.

• KTRS MEHP Part D Prescription Drug Plan continues with Express Scripts through 2023.

- Express Scripts Mail Order-Alternatives (generic) per 90 days at Express Scripts mail Order (1-877-866-5834 or www.Express-Scripts.com)
- Know Your Rx Coalition *Pharm-Assist* (1-855-218-5979) Direct access to **pharmacists** to help with: Prescription questions, Answer question about MEHP coverage
- Coriell Life Sciences (1-888-454-9024) DNA testing Genetic testing wellness program with about 7,300 members participating
- SilverSneakers (1-888-423-4632) continuing free
- Renew, Real Appeal, Mom's Meals, Teladoc
- Register at www.UHCRetiree.com/trsto see these features available to you or call 844-518-5877 for more information.

KEHP Kentucky Eligible Health Plan 2022 (under 65)

- Same fund as active teachers and state employees, coverage options
- Passive enrollment (do nothing) for 2022 unless changes are needed
- KEHP consists of:
 - Anthem
 - CVS CareMark
 - Know Your Rx Coalition
 - WageWorks (may use Wageworks card to pay for DNA testing)
 - StayWell WebMD
 - Complete Living Well Promise each year by July 1 (Health Assessment or Biometric Screening). The penalty if Living Well Promise is not made by July 1, is a Premium charge of \$40.00 extra per month.

(Before you move from the KEHP to Medicare, remember that StayWell points and WageWorks account funds do not continue to Medicare and the TRS MEHP - so use them before you switch.)

Teacher Shortage

The Kentucky Legislature has passed a law allowing you to return to district work <u>without any penalty to your retirement</u>. This means if you return to JCPS full time, you will earn at least \$385 per day – the equivalent of \$71,000 per year PLUS your full pension. Part time positions are also available.
