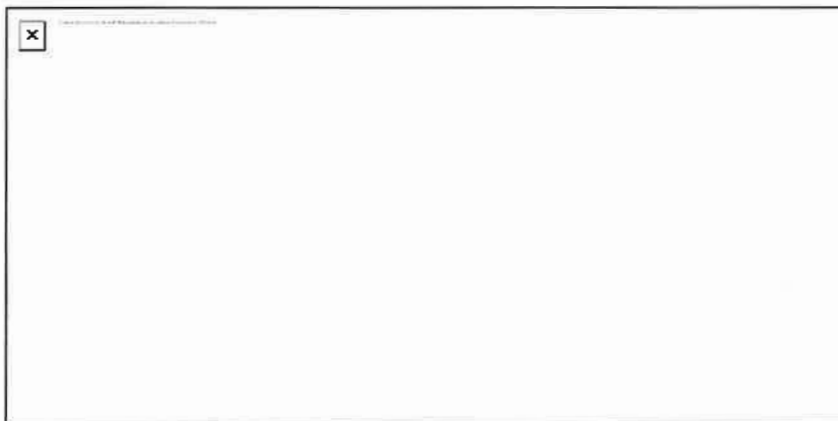

On 06-06-23, approximately 1500 hrs, I spoke to V-Gooch via phone reference Threats.

V-Gooch's address is [REDACTED] V-Gooch said he was checking his email today and noticed a Threatening Email(see attached). V-Gooch said the email was sent on 05-25-23 from an anonymous sender using Guerilla Mail. V-Gooch said he owns a company in Florida that removes video's from Youtube for copyright issues. V-Gooch said the suspect sent him an email telling him to quit harassing people on Youtube. The suspect goes on to tell V-Gooch that he knows where his chubby son goes to school and he will visit the school and blow his brains. The suspect also mentions school shooting. V-Gooch said he does not know the suspect. I attached a cpoy of the email sent.

OfficerID: COENT\CookC, Narrative

On 06-12-23, I found out the email that was used came from Guerrillamail and the company is out of Germany. Guerrillamail is set up as a temporary email site. I spoke with Curtis Gooch and he told me he is almost certain the suspect in this case is Andrew Sgambati from Ohio. He told me he has an ongoing issue with him posting videos and he has to go and shut them down for his business (which is out of Florida).

On 06-13-23, I spoke with Andrew and he told me he did not send anything to Curtis. I told him to cease all communications with Curtis and he told me he understood.

On 06-29-23, I was contacted by FBI Special Agent Lisa Dungan and she told me she also made contact with Andrew and that he had denied sending the email to Curtis. Additionally, Andrew stated he has not intention to travel to Oklahoma for anything.

It should be noted this case involves a longstanding civil dispute between the two parties.
