- This contract is an agreement between Great Plains Frenchie, LLC (referred to as seller from here on out) and Jane Doe (referred to as buyer from here on out) for delivery of a puppy to the buyer or authorized representative.
- **Air Transport fees** - One (1) round trip ticket + carry-on bag from Omaha, NE to buyers preferred destination, One way cabin pet fee for one (1) puppy. Great Plains Frenchie does not charge any additional fees outside of the costs set by the airlines for air travel. Travelers' insurance is encouraged, but not required, however If not purchased and the flight is cancelled by the airline for any reason, the buyer will be responsible for any additional airfare costs or will need to pick up the puppy from Omaha, NE within 7 days of the cancelled delivery date.
- **Ground Transport Fees (20 to 500 miles from Omaha, NE)**
 - ❖ 20-250 miles from Omaha, NE - Round trip fuel costs calculated at the average national rate at the time of delivery + 50 service fee.
 - ❖ 250 to 500 miles from Omaha, NE - Round trip fuel costs calculated at the average national rate at the time of delivery + 100 service fee + 1 night hotel stay (up to \$100)
- Air Transport is required to be paid AT LEAST 10 days prior to delivery date.
- Ground Transport is required to be paid AT LEAST 5 days prior to delivery date.
- If the delivery fees are not paid in full by the deadline date listed on page 2, the buyer will have the option to pick up the puppy by the date listed on the purchase agreement. If approved by Great Plains Frenchie, the deadline date for delivery may be extended and a \$100 convenience fee will be applied on top of transport fees.
- The puppy is guaranteed to arrive at the location in good health and without injury. If the puppy should become too sick or injured to release from the sellers during transport due to the neglect or carelessness of the seller, the buyer will be entitled to a full refund of travel expenses and puppy deposit.
