# Annual Report 2021

*Service Statistics for the period of  
January 1, 2021 – December 31, 2021*

**Harmony Home served 968 children and their non-offending family members. A 13% increase from 2020**

**580 forensic interviews were conducted.**

**1062 hours of therapy were provided to 150 children and 96 non-offending caregivers.**

**2372 victim's services and referrals were given to 327 families**


**53 Stewards of Children Trainings completed.**


**1,170 adults trained through Stewards of Children.**

**16,110 children trained in Child Safety Matters grades K-5th**





## CPS Confirmed Child Abuse Cases











## Forensic Interviews of Child Abuse Cases at Harmony Home CAC






# Therapy Sessions for Child Abuse Victims at Harmony Home CAC
