President's Message

May 2016

SINE DIE ---THE LEGISLATURE IS CLOSED FOR BUSINESS FOR ANOTHER YEAR.

Thanks to all of you that stayed in the trenches during the whole agonizing process and continued to submit testimony in OPPOSITION to the horde of bad gun bills that were thrown at us this session. Three of the worst bills have made it through the process and are at the Governor's office for his action or inaction.

HB 625: Misdemeanor harassment as a disqualifier for firearms possession.

HB 2632: Confiscation of firearms from persons taken in for emergency hospitalization.

SB 2954: Rap Back: puts all applicants for firearms on a Federal Registry.

Governor Ige has three basic choices regarding these bills: 1.) Do nothing and

allow them to become law, 2.) Sign the bills with his approval and they become law, or 3.) VETO the bills so they do not become law.

We have asked the Governor to please VETO all three of these bills for a myriad of reasons, all of which we have covered in great detail in previous newsletters and in our alerts to our membership. The NRA, our partners in the Hawaii legislative effort, has helped us immeasurably by providing us access to their highly developed Alert System, which sends letters to the appropriate legislators and the Governor regarding our wishes for certain Bills. This system makes it very easy for our members to send out pre-written letters to the legislators with the push of a few buttons.

We still have a chance that the Governor will VETO all these bills, but that is a long shot at this juncture. We are in conference right now considering lawsuits to challenge the Constitutionality and Due Process of these bills and will keep you up to speed with our decisions.

Letter from LIFE

Aloha LIFE'ers,

Recent news stories have pushed the Honolulu police chief into the limelight, which has pushed a question of fairness and equal protection to the surface: should any citizen, regardless of their job, be treated differently for the same "crime?"

I am not taking sides on the issues surrounding the legal problems the chief is going through, but rather questioning whether he should be immune from the edicts the rest of "us" would otherwise be subject to if we were in the same legal predicament.

The issue is what happens if the grand jury hands down an indictment. If you, or I were to be indicted, we would, under Hawaii Revised Statutes (HRS) 134-7 be prohibited from owning, possessing, or controlling a firearm or ammunition. But, there is another law, HRS 134-11 that specifically exempts police from having to turn in all their guns or ammunition.

This exemption brings up a couple of questions. The first is why Hawaii prohibits those under indictment from having firearms. The grand jury process is a closed proceeding where the only evidence presented is from the prosecutor. There is no effort to allow a rebuttal to the charges or to offer exculpatory evidence. In a recent interview with a local news station, employment law and worker's rights lawyer David Simons correctly noted that being indicted was not the same as being found guilty. "You could also argue that you're innocent until proven guilty and the mere factor you're going to be indicted, under the American system of justice, does not prove guilt at all..." he said.

And since an indictment is not a finding of guilt, under what circumstances would it be appropriate, or constitutional, to deprive someone of their legal rights based solely on an indictment? Furthermore, what rights should be affected? Obviously, the state of Hawaii thinks it would be OK to restrict your Second Amendment rights, but why not your First Amendment (freedom of speech and religion) rights, or your Fourth (unreasonable search and seizure), Fifth (right to remain silent) or Sixth (speedy trial) Amendments? I suspect that most people that support this restriction to your Second Amendment rights would find applying it to other rights excessive and, dare I say it, unconstitutional. Can you imagine being told you cannot post your opinion on a blog or a letter to the editor, or go to the church of your choice because you were under indictment? What if the police could pull you over, search you, your car or your house without a warrant or probable cause, just because you were under indictment? Or, if the authorities could hold you indefinitely without trial, based just on the indictment? Would anyone think that would be OK? I doubt it, yet when it comes to owning firearms, no one seems to give it a second (pun) thought.

The second question is why should the police be exempt from the provisions of the law that everyone else has to suffer under? What makes them, and not the Mayor, or the Governor, or a priest or anyone else, special? If anyone knows me, they know I am NOT anti-police, so this is not

about police per se. Let me say that again, just so there is no confusion. This is not about the police nor is it in any way a comment about the police in general. I would be asking the very same questions if senators or representatives received the exemption. If we, the citizens are too dangerous to own firearms once indicted, what makes any other group somehow less dangerous?

Every once in a while there is an internet posting that makes the rounds, asking for a Constitutional amendment that would force our law makers to adhere to the laws they create, making themselves exempt from them would be illegal. The sentiment of the story is that we should all be treated equally, and that those who make the laws should not be exempt from the provisions of those laws. And, that all laws should be applied equally, regardless of your skin color, your income, your family name, or your profession.

And, unless you believe the statement from George Orwell's book, 1984, that "All animals are equal, but some animals are more equal than others," then the only right and ethical thing to do is to treat everybody equally in the eyes of the law. After all, isn't that the reason Lady Justice wears a blindfold?

WHAT'S THE LAW?

TOPIC: Straw Buyer

Question: I attended the March Gun Show with a good friend. I had my long gun permit, but my friend's permit had expired and he did not renew in time due to the long lines at HPD. At the Show, my friend saw a rifle he wanted. I offered to use my permit since he didn't have one. But he decided not to buy the rifle. My question is: Did I risk violating the straw buyer law and being subject to jail time — even as a federal offense?

Answer: Perhaps. And it depends if the seller was a FFL dealer or an individual. A firearms straw buyer is a person who is legally qualified and does purchase a firearm but intends to turn over possession to a person who is not legally qualified. Without a permit, your friend isn't qualified.

This would be unlawful if buying a firearm from a FFL dealer. Question #11a of the ATF Form 4473 (so called "yellow form" a buyer completes when purchasing a firearm from an FFL) states: "Are you the actual transferee/buyer of the firearm(s)...?" If you are buying the firearm for your friend, you may well be in violation of federal law by making a false statement to this question. This is a felony and carries with it a maximum penalty of 5 years in jail and a \$250,000 fine.

The better way is for your friend is to give the FFL dealer a deposit or pay in full. Have the dealer hold the firearm while your friend obtains his permit.

If the seller is not a FFL dealer, the purchase by you may be lawful since there is no Form 4473 or statement required. Show the seller your long gun permit. Register the firearm in your name at HPD within 5 days. You must maintain actual possession of the firearm. When your friend obtains his permit, you can then transfer the firearm. But this is a hassle. Much easier just to give the seller a down payment and have your friend complete the sale and transfer after he gets his permit.

If you are a FFL, you cannot allow a straw buyer purchase. Best to have the buyer make a deposit and transfer the firearm after the 14-day requirement. If you are a private seller, it is still best to take deposit and wait out the 14 days. An interim private sale may not be illegal under Hawaii law, but your buyer must register the gun in his name within 5 days and you must send in the notice of transfer within 48 hours.

Added note: As a seller, it may be best to tell your buyer the deposit is non-refundable, since you will be taking the long gun off the gun show table and giving up opportunity to sell it to a qualified buyer if the sale falls through after the show.
