

### **Annual Meeting Update**

Your Hawaii Rifle Association held its Annual Meeting and Thank You Shoot (for the Shooting Sports Fair volunteers) on August 28, 2016. The two meetings were combined due to the Thank You Shoot being cancelled due to bad weather on a previous date.

Thank you to all our members who have stuck with us throughout the year and responded to our emails requesting testimony of "anti-gun bills" that keep popping up at the legislature. This year was especially bad because the new major in charge of the Honolulu Police Department Firearms Division has decided lots more useless laws restricting your rights as a law abiding citizen will somehow enhance the safety of the community. Unfortunately, our legislature went along with HPD's requests and enacted some of them into law. PLEASE, when you receive the alerts, respond as soon a possible and submit testimony. We have made it very easy to submit testimony on the automated system. Writing letters to your legislators is also a very powerful way to respectfully educate them on your views and opinions regarding pending legislation. Our legislators need to know how many of us there are in their communities, and they will only get that message by your participation in "the process". It only takes a few minutes to register on the State of Hawaii system and to request notification of the "gun bills" that are moving through the system. We will provide the listing of the bills we are concerned about for your action. When the hearing notices go out there is very little time to make your voice heard, generally less that forty eight (48)hours, and sometimes as little at twenty four (24) hours, so keeping up with the process is key to our success.

Your Board of Directors has worked diligently over the past year and I would like to thank them for all their efforts. They are: GORDON OSHIRO, CHARLIE DAVIS, CHAD DIAS, CLIFF GOO, LYLE HIROMOTO, BRANDON LEONG, RON LIVINGSTON, AL MONGEON, DANIEL OSHIMA, BILL RICHTER, MARK GENOVESE (Maui), GLENNON GINGO (Big Island, Kona), and RICHARD HOEFLINGER (Big Island, Hilo).

We meet once a month to discuss and plan for all the upcoming events and what needs to be done to implement those events. Planning and implementing the publicity to increase the awareness about the shooting sports and supporting the high school shooting programs is of key importance to our mission.



# Koko Head Skeet Club (KHSC)

June 18 and 19, 2016

Hi Shooters:

Father's Day Weekend at Koko Head Shooting Complex is like a beehive come alive. There are hundreds, if not thousands, who braved the hot sun and ventured out to seek some fun and excitement. The HRA Shooting Sports Fair does not disappoint--it is full of activity. Lots of gunfire and so many exciting and different firearms to choose from, it gives one pause to say, "let's try to shoot them all." It is a tall order at best to try and imagine accomplishing that feat, but I am sure there were many who gave it the good old American try...all in good fun.

Skeet was there to fill the bill in the shotgun department. We had our tents all set up and ready to go by the 10:00am start time. I thought this year was a little slow in the beginning, but in an hour, it was definitely going strong and it did not really let up for the whole day. The skeet crew had them signed in, briefed on safety, given a shotgun demo, and away they went to redeem their scrips for the shotshells of their choice-- whether it was 12 ga. or 20 aa., and after a brief wait under the protective cover of our broad tents, they were on the line with either Max or Tai to take their chances on breaking a few, or all, of the targets thrown. The familiar report of the shotgun and the breaking of a target gives pure joy to the shooting public. I have seen them literally jump for joy and gleefully scream their delight at the busted target, and from this side of the fence, it is so gratifying to see someone really take a huge step into understanding shotguns and the clay target. You cannot describe that feeling... vou have to witness it to believe it.

Koko Head Skeet Club has been a partner to the SSF for the last six years, and since that time, we have helped with the mission to educate the public on the shooting sports in all its disciplines. There are rifles, pistols, shotguns, military type firearms and even semi-automatic machine guns that grace the public fantasy. We endeavor to educate the public and we are responsible gun owners, who collectively each year, try to give the public a look with a hands on approach to the shooting sports. Want to shoot a certain type of firearm? It is likely we have it at the shooting fair, giving you a great opportunity to try before you buy. We also like to promote the shooting sports with theirs and our safety in mind at all times. We mandate eye and ear protection and advocate safety first, middle and last. All participants desiring to use our firearms need to be screened before they can proceed to the different shooting venues, and at skeet, we have our own safety instructions that we insist be followed before a person can shoot our shotguns. All this is for one thing and one thing only--safety. We cannot stress that more.

Skeet had two great days again this year. Saturday, as I mentioned started out a little slower but it was non-stop the rest of the day. On Father's Day itself, I guess dad got permission and a pass to get out and do his thing and many did it at the shooting fair. Sunday was definitely busier and the last shooter took his clay straight up at closing at 4:00pm. It was a very busy weekend and if you were there, all I can say is I hope you had a good time. We certainly were busy enough to be exhausted at the end of each day.

Some of our stats for the weekend were slightly off from last year but not by much. We sent downrange 3832 rounds of 12 ga. and 20 ga. collectively, and that means we threw no less than 3832 clay targets. To put it in another perspective that is nearly 16 cases of shotshells and nearly 29 cases of targets. It was a busy weekend indeed.

KHSC would like to thank the volunteers who helped with the set-up of the tents and equipment on Saturday and they would be Max Yasukawa (Rangemaster) and Tai Chong (Assistant Rangemaster), Louise Mott, Alden Almeida, Clyde and Gayle Nishimoto, Brad Wong, Marc Lizama and Neal Yoshimura. Thanks for coming out early to make sure that we were set-up on time. On Sunday, we had repeats with Max, Tai and Louise, along with Mery and Sterling Luna, Pete Nishi and Cherie, Mike Cullen, Allysa Leavey and Ted Guillermo sharing the duties and of course helping to bring down all the equipment at the end of day. It was very much appreciated. This year, we had a special treat with none other than our "Sign Girl" advertising Skeet for us during the rush hour and that would be our own Allysa.

Along with the volunteers that help to make the events run smoothly, there are the behind the scenes volunteers that help the shooting public enjoy our sport of skeet. Each time we pull the trigger two things happen, we expend a shotshell and we also launch a clay target. This is one of the things that is unique to only the clay target sports, that makes ours an expensive venue at best. We



Sadly, DLNR's indifference to hunting and its lack of game promotion, coupled with political and environmental tunnel vision, presents a missed opportunity to acquire significant State tourism revenue from mainland hunters.

Grabbing the cheap Bushnell glasses I keep in the truck, I picked him up again, far, far below – slowly threading his way through Mamane and Pukiawe brush toward the unsuspecting animals.




