## *MEMBERSHIP Overview:*

As a co-op gallery, it is the members that run everything, there are no employees. That being said, the tasks that will take most of your time are...

**SITTING** - all members are required to sit, which is split up by the number of members. Depending on the number of members, it could be 10 - 15 days. Our hours are currently 10:30am - 4:00pm, any change to those hours would be voted on by the membership. We are open from, end of June until the beginning of September. Each member is responsible for following all procedures set by the membership for sitting, which includes handling sales, the required daily accounting and artist notifications that goes with each sale.

**SHOWS** - We have 3 shows during the summer - so tasks associated would be Receiving, Hanging, Label Making etc. This also means there are 3 receptions during the summer, for which each member is encouraged to attend and provide some type of hors d'oeuvres. Receptions are Friday nights 4-7. Current schedule is on the website and is reviewed and revised each year.

**CO-OP JOBS** - All members are expected to fill a position or take on at least one task such as President, Treasurer, Gallery Manager, Social Media, Special Event Coordinator, etc. Those are discussed and decided at the new member meeting in February.

**MEETINGS** - We do have a few meetings during the off season - end of year review, new member planning (if needed) and next season planning, at the minimum.

**DUES** - are decided over the winter, based on what is needed for the gallery bills, this is usually \$150-\$200. Any changes to dues are recommended by the President and Treasurer, and decided by the membership before the upcoming season.

**COMMISSIONS** to the gallery - are decided over the winter, and is currently set at 25%. This is reviewed each year and is voted on each year based on the recommendations of the Treasurer in order to cover gallery expenses.

The above is a highlight of the commitment needed to be a gallery member. Please feel free to speak to any existing member to get a greater understanding of the roles and responsibilities of being a Red Barn Gallery member.
