Narrative

On Thursday November 6th at approximately 1100 hours, I Deputy Sheriff [REDACTED] was approached by [REDACTED] from [REDACTED] in reference to a telephone call she received from a gentleman identified to her as Jeremy Hales, the telephone number on the caller ID (330-641-6301) who provided her information on a current teacher named [REDACTED]. My investigation revealed the following:

[REDACTED] said Hails told her [REDACTED] she's a very dangerous individual she faked her own death to avoid being disbarred as an attorney, she has an only fans page, she's a paid harasser/agitator and other examples to include her creating images of him as Hitler killing Jews. After the phone call ended, [REDACTED] notified the proper school authorities. Short while later, fellow staff employees started receiving an e-mail (ocps.net accounts) in "parent square" from a "concerned citizen". The email read "You need to know who [REDACTED] really is" then a hyperlink to a YouTube page: <https://www.youtube.com/live/Ul8h8jlzXos?si=W9z3yQPBUVNucG7S>. I did not click the link and I have not talked to any fellow employees who did.

A short while later I met with [REDACTED] who told me the following: she is a former family court attorney and worked for the Department of Children and Family Services previous to becoming a school teacher, she was approached by an unknown podcaster to give her professional opinion on a case filed by Mr. Hales the day after she was on the podcast the harassment started.

[REDACTED] advised Hales runs a YouTube channel with approximately a million followers, she believes name of the YouTube is called "what the Hails". Hails talks about her and approximately 12 other individuals. [REDACTED] said the platform is used to post personal information about her as well as AI generated images and videos of her likeness all of these are posts with malicious intent that has caused a mental effect on her well-being. [REDACTED] told me that she believes this all started in believe she said it was March of 2025 she has taken numerous actions to try and delete her social media all of her profiles and because of the continued electronic harassment from Hales and his followers which he encourages other to join in. She filed a defamation lawsuit against him which she later ended up having to drop due to financial strain. She has also contacted You Tube to report a possible violation of their terms of service. You Tube did not agree, she believes they may have denied this as he is "monetized/compensated". Hails then use the lawsuit as another vehicle to create harassment. Hales is very resourceful, he knows how to submit public records requests and has done everything he possibly can to find about [REDACTED] which he publishes. This ongoing course of malicious actions toward her led to an attempt to take her life. She does have several examples and documentation to support her claim, which she can provide upon request. [REDACTED] signed a sworn written statement desiring prosecution and will testify. Due to the nature of the possible crimes committed and the sensitivity, she does wish to invoke her right to Marcie's law for any redactions that can be made from public records. I provided her with a victim's right pamphlet as required by law she did sign the victim's request for confidentiality.

When I ran [REDACTED] two past Orange County Sheriff's Office case numbers were discovered 19-080885 "General Investigation" and 22-018001 "Harassing/stalking".
