| NARRATIVE | <p>On January 7, 2026, at approximately 1237 hours, I, Officer Kadry (40150), along with FTO White (32445), responded to 1250 W South Street in reference to a battery call.</p> <p>Upon arrival, I spoke with the victim, later identified as [REDACTED], who provided a written, sworn statement stating the following. [REDACTED] noted on December 13, 2025, at approximately 1210 hours, the suspect, later identified as Jeremy Bryan Hales (DOB: 03/30/1977), had battered her by grabbing her breast and her pants without her permission.</p> <p>[REDACTED] stated she has a YouTube channel and posts content, some of which she posts in reference to YouTube videos posted by Jeremy. [REDACTED] stated that Jeremy is known for filing multiple lawsuits, and one of the lawsuits involves her friend. Jeremy's YouTube channel is called "What the Hales".</p> <p>[REDACTED] stated on the day of the incident, she had met up with Jeremy at the Extra Space Storage unit located at 3820 S Orange Ave. [REDACTED] stated Jeremy met up with her at the storage unit so he could get some information about her friend that Jeremy has a lawsuit against. Jeremy believed [REDACTED] had information relating to [REDACTED]'s friend on her phone.</p> <p>[REDACTED] stated while she was there, Jeremy grabbed her breast and her pants without her consent. [REDACTED] stated Jeremy reached his hand under her shirt, on top of her bra, and grabbed her breast. [REDACTED] further stated Jeremy grabbed her pants. [REDACTED] stated after he battered her, she continued to help him move items in the storage unit.</p> <p>[REDACTED] noted there is no relationship between her and Jeremy. [REDACTED] only provided Jeremy's name and date of birth. Through investigative means, I was unable to locate any further information about Jeremy. I</p> |

located one potential lead; however, there was no picture attached to the lead.

It should be noted [REDACTED] has filed a police report with Levy County against Jeremy for an extortion case #26010072. Please refer to the Levy County report for more information regarding this case.

Officer White spoke with the manager of the storage unit, and he said the video saves for 30 days before it is deleted. All he requires to collect the video is credentials and the OPD case number.

Officer White sent an email to the OPD video lab requesting the video footage of the front camera at the Storage Unit for evidence of [REDACTED] and Jeremy entering the storage unit together. It should be noted the manager at the storage unit stated there are no cameras available in the hallway. Therefore, there would not be video footage available of the battery incident.

[REDACTED] signed a declination to prosecute and wanted to report this incident for information purposes only at this time. She desired Marsy's law. I provided [REDACTED] with the victim's rights booklet. This incident was captured on my issued body-worn camera.

On January 13, 2026, at approximately 0900 hours. I, Officer Kadry (40150), along with FTO White (32445), responded to 1250 W South Street in reference to a follow-up for an Orlando Police case# 2026-00007403.

Upon arrival, I met with [REDACTED]. [REDACTED] stated in reference to case#2026-00007403 that she now desires prosecution.

At this time, [REDACTED] could not provide a phone number for Jeremy. I did not find a photo of Jeremy so that [REDACTED] could identify him.

It should be noted that [REDACTED] has an ongoing case with the Levy County Sheriff's Office against Jeremy that she believes is not making any progress.

[REDACTED] did not claim any injuries from when the incident occurred. It should be noted that [REDACTED] stated that she continued to help Jeremy pack his items at the storage unit after the battery she claimed occurred. [REDACTED] also waited a month to report this incident to the Orlando Police.

On December 13, 2025, at approximately 1146 hours, [REDACTED] appeared on the front entrance camera at the storage unit, meeting with a white male whose description matched [REDACTED]'s description of Jeremy. Jeremy was already at the storage unit, and he walked out with a cart full of items, and some of the items dropped on the ground. When [REDACTED] noticed Jeremy, she waved at him, approached him, and hugged him. [REDACTED] then helped Jeremy pick up the items that were dropped on the ground back on the cart. [REDACTED] picked up some items off the ground and loaded them into a trailer that was parked by the front entrance.

At approximately 1150 hours, Jeremy, along with [REDACTED], entered the storage unit with an empty cart, and at approximately 1219 hours, both of them exited the storage unit with a loaded cart, and [REDACTED] was seen helping Jeremy push the cart into the trailer. After unloading the cart, they entered the storage unit at 1221 hours, and [REDACTED] was pushing the empty cart by herself, following Jeremy back into the storage unit. At approximately 1230 hours, [REDACTED] and Jeremy exited the storage unit with more items on the cart, and [REDACTED] continued to help him load the items onto the trailer. At 1233 hours, Jeremy and [REDACTED] enter the storage unit again with an empty cart. At 1245 hours, Jeremy and [REDACTED], each pushing a cart full of items to the trailer, and [REDACTED] helped load the items into the trailer. This concluded the video footage available at the front entrance. It should be noted that there are no cameras inside the storage unit that would have captured the alleged battery.
