# GREEN CONSUMER

The Supreme Court of India has taken significant action against Patanjali Ayurveda Ltd. for allegedly spreading misleading advertisements. This action highlights the importance of truthfulness in advertising, especially in India's competitive consumer market. Patanjali's rise in the FMCG sector has been accompanied by concerns about the accuracy of its promotional claims.

The court served a contempt notice to Patanjali and its director for violating previous commitments to refrain from misleading advertisements, particularly regarding medicinal cures. Despite warnings, Patanjali persisted in publishing deceptive claims, leading to the court's intervention. Patanjali issued an apology to the Supreme Court after being summoned to explain their actions. However, the court expressed dissatisfaction with their response and gave them a final chance to rectify their behavior.

This legal action underscores the importance of accurate advertising in protecting consumer rights and public health. It reflects a global trend of holding corporations accountable for their marketing practices. In India, the Consumer Protection Act empowers consumers against misleading advertisements, highlighting the need for ethical advertising practices. The contempt notice to Patanjali serves as a warning to all companies to exercise responsibility in their marketing communications. It reaffirms the court's role in upholding justice and fairness in society and emphasizes the duty of companies towards consumers and society at large.

This case underscores the significance of ethical advertising practices and consumer protection. By adhering to these standards, companies can avoid legal issues and contribute to a healthier market environment. The outcome of this legal battle will shape the future of advertising regulation and consumer protection in India.



## SILENT JUSTICE - D. SRI LASYA

The Telangana High Court affirmed that the right to remain silent is a fundamental right protected by the Constitution of India under Article 20(3). Consequently, the investigating authority cannot file a second application for an extension of police custody solely because the accused remained silent and did not provide satisfactory answers. Despite this, the trial court granted the National Investigation Agency's (NIA) application for custody extension. In response, a revision was filed challenging this decision. After a thorough analysis of legal provisions and established precedents, the Bench determined that a second application for custody extension could be submitted after the initial 30-day period. However, it mandated that the investigating authority must accompany the application with an affidavit detailing the reasons for the request and addressing any delays. Consequently, the High Court held that while the NIA's application for extension was valid, the reasons provided were insufficient in this specific case. The court emphasized that the NIA's contention of new evidence emerging against the accused, necessitating confrontation during custody, did not justify delay in filing the application.
