## Professional Photography & Videography

On big cruise ships like this, guests are typically not permitted to use professional photography. **HOWEVER, Norwegian is allowing us (even encouraging us) to make use of the ship and offer photography & videography services to our group.** They have offered to schedule public areas of the ship exclusively for Senpai Cosplay Cruise photo shoots which, during that time, will be closed off to other guests.

**In order to be featured on the SCC 2019 "Services" page of the website, you must make a deposit, apply, and be approved.** This guarantees a level of mutually beneficial professionalism for the Group and the Cruise Line.

- Any Event Specials or Event Pricing (if applicable)

If you're selected to offer services, we'll include the above requested info on the Services page of the website with a link for guests to contact you and book with you separately.

**All of the artists offering services (photographers, MUAH, videographers etc) to the SCC 2019 Group are doing so of their own volition.** They are not employed by SCC 2019 or Norwegian. All artists must buy passage on the vessel using the group rates, just like any other participant.

**There will be a cap on the number of photographers, videographers, and makeup artists** if we start to get too many for the number of participants involved in the cruise. So far that hasn't been an issue. If it does we will provide the cap number.

Please be aware we do not facilitate your booking and are not responsible for any issues with artists or clients requesting services before, during, or after the cruise.

## Respect Norwegian's Policies

**All artists must know and be aware of Norwegian's policies and follow the rules of the ship.** No permanent marks, setups, or stations of any kind will be permitted. By sending your information to be an artist offering services aboard the cruise (or during docking) you are agreeing to all the policies of the ship and Cosplay Senpai Cruise.

**\*\*\*This is a private event. Artists are not allowed to offer services to anyone outside of the SCC group, as this would really upset the Norwegian people. Photography and Videography must be limited to our Group, and may not be taken of other passengers. NCL will be strictly enforcing the privacy of their guests who are NOT in our group.\*\*\***
