DISCLAIMER: This Waiver and Release Agreement is applicable to all renters, passengers, and users of equipment provided by Salty Crook, LLC (For purposes of this Waiver and Release, the term "Salty Crook" includes all principals, directors, officers, employees, agents, representatives, servants, assigns, successors, insurers and subsidiaries of Salty Crook, LLC). The undersigned agrees that he/she is also signing this Release on behalf of next of kin, heirs and representatives.

I. PASSENGER DISCLOSURE: The undersigned agrees that he/she will disclose to Salty Crook all potential passengers and users of said rental equipment. The undersigned further agrees that in the event that he/she fails to notify Salty Crook of all potential passengers, or users of said equipment, he/she will be personally liable for any damages to the undisclosed individuals, even if such damages arise out of the negligence or fault of Salty Crook.

II. ACKNOWLEDGEMENT OF RISKS: The undersigned acknowledges all risks of participating in watersport activities, rental, and use include but are not limited to: 1) Changing water flow, currents, and watercraft wakes or waves; 2) Collisions with other participants, the watercraft, other watercraft, and manmade or natural objects; 3) Collision, capsizing, sinking or other hazard which results in wetness, injury, expose to the elements, drowning and/or death; 4) Attack by or encounter with insects and marine life forms; 5) Equipment failure or operator error; 6) My sense of balance, physical coordination, ability to operate equipment, swim and/or follow directions; 7) Wind, inclement weather, lightning, variances and extremes of wind, weather, and temperature, 9) Heat or sun related injuries or illnesses, including sunburn, sunstroke or dehydration. Unknown or unanticipated risks may also result in injury, illness or death.

III. EXPRESS ASSUMPTION OF RISK: The undersigned agrees that he/she is renting and using the equipment provided by Salty Crook at his/her own risk. The undersigned agrees that he/she is voluntarily participating in all activities related to the rental or use of the rental equipment, The undersigned assumes full responsibility for all risks of personal injury, damage, loss, accident or illness; as well as any resultant expenses from all risks undertaken, regardless of the cause, even if the risks arise out of the negligence or fault of Salty Crook.

IV . Further, in consideration for rental and use of equipment from Salty Crook, I release from all liability and promise not to sue Salty Crook from any and all claims as stated that may occur as a result of my participation, rental, and use of equipment from Salty Crook. I further agree to hold Salty Crook harmless from any and all claims, including attorneys' fees and all damages. If Salty Crook incurs any of these types of expenses, I agree to reimburse Salty Crook. If I need medical treatment, I agree to

V . LIABILITY TO THIRD PARTIES: The undersigned agrees that he/she will indemnify and hold harmless Salty Crook for all personal injuries, property damages, or any other damages to any and all third parties, including but not limited to, passengers of other watercraft as a result of any and all activities related to the rental or use of equipment provided by Salty Crook even if such damages arise out of the negligence or fault of Salty Crook.

VI. ACKNOWLEDGEMENT OF WAIVER AND RELEASE: The undersigned states that he/she has had sufficient time to read and review the Waiver and Release, as well as to ask any questions associated with said Release to understand the provisions as stated.
