Scholarship Rules

1. **ONLY FULLY** completed applications will be awarded \$3,000.00. Partial/incomplete applications will be disqualified.
2. The Scholarships are granted without restriction or special consideration as to race, religion, or creed, and are selected by a committee composed of professional, educational and/or business leaders who are non-affiliated with the Polish Legion of American Veterans Organization or Auxiliary in any manner.
3. Scholarships will be made payable to the student and the school, and will be issued the month of June, upon proof of enrollment to an accredited American College, University, or equivalent Vocational School. (**LETTER OF ACCEPTANCE MUST ACCOMPANY THE APPLICATION**) A letter of notification will be mailed to the winning recipients of the Scholarship Grant in mid-May 2025.
4. **APPLICANT MUST BE:**
 - A. Related to a current and eligible Department of Michigan member of the Polish Legion of American Veterans or Ladies Auxiliary.
 - B. A citizen of the United States of America.
 - C. 17 to 25 years of age.
 - D. High School Senior (12th grade), or currently attending an accredited American College, University, or equivalent Vocational School.
 - E. If in college, must carry a minimum of 6 credit hours per semester/quarter.
5. **SCHOLARSHIP APPLICATION:**

Part I: To be completed by a school counselor or teacher.

Part II: To be completed by applicant and family member.

Do not use the same person for Part I and Part II.

An Official School Grade Transcript MUST accompany the application(s)

Student's name **MUST** be imprinted on transcript. (These may be obtained through the schools' website, if the student's name is printed on the transcript.)

Completed application(s) must be returned by: April 30, 2025

Envelopes MUST be postmarked NO LATER THAN APRIL 30, 2025

NOTE: IF USING INTERNET POSTAGE, PLEASE MAKE SURE YOUR SETTINGS ALLOW FOR A DATE TO APPEAR ON THE POSTAGE METER STAMP. THE DATE MAILED MUST BE VISIBLE ON THE ENVELOPE!

It is suggested, but not required, that all applications be mailed via Certified Applicants' benefit, to ensure their paperwork was received in a timely manner!

Please print or type the application, and before mailing it, make sure you have answered ALL the questions, and provided ALL requested information. Sometimes, 1 missed question, and being unable to contact the applicant to follow-up, can and has resulted in a disqualification of the application.

And lastly, please provide a primary and secondary means of contact should we need to follow-up with you. Only current year 2025 applications will be accepted.
