Regularly patrols county roads and designated areas, ensuring the security of residences and businesses, investigates and reports all suspicious or unlawful activities and performs necessary actions to ensure the proper enforcement of applicable laws. Responds to citizens' calls and complaints of alleged unlawful activities, takes statements from victims and witnesses and ensures the lawful arrest of criminal offenders. Participates in the formal investigation of crimes and accidents. Performs traffic control duties, providing assistance to motorists as needed. Assists the courts by serving warrants, attachments, subpoenas, summonses and related process papers. Transports individuals detained by the county to appropriate courts, detention or medical facilities. Prepares and submits required reports and summaries of daily activities. Testifies in court as required. Performs related duties as assigned by the Sheriff or his designee.
