50% minimum deposit is required prior to the commencement of work. Accepted forms of payment: Venmo (@Sierra-Langbell), PayPal (slangbell@yahoo.com), Cash, Check, & Credit Card.

By signing below, I state that this animal was taken legally in compliance with state and federal game laws. I understand that due to factors beyond Sierra Langbell’s control - such as field care – all tanning, whether done in house or otherwise, is done at specimen owner’s own risk. I also understand that if the mount is not paid for in full and picked up within 30 days of being notified of completion, it becomes property of Sierra Langbell and deposit will be forfeited. If a game warden confiscates the specimen and has concerns about the legality of the harvest - deposit will be forfeited. I understand that estimated completion dates are tentative and subject to seasonal demand and other wavering factors. I recognize that certain positions, habitats, bases, and added time will all cost extra and will be added onto the final balance. Sierra Langbell and her employee’s will not be held responsible for the loss or damage of specimen(s) or other substances resulting from: theft, fire, flooding, loss of power, vandalism, third party loss or damage, or any other circumstances or acts of God that are beyond our control. Checks returned for any reason will result in a \$50 check return fee. Any cancelled orders will result in a \$50 service charge. I understand that the cost of shipping must be paid by me, the client, in full before the mount can be shipped. There can be NO cancellations after the work has begun.
