

# Hoosier Sire Program Rules

## Eligibility

**Stallion Eligibility:** Stallions must be registered and current on licenses with the American Haflinger Registry. Stallions must be 100% owned and standing in Indiana to be eligible as a Nominated Indiana Stallion in the Hoosier Sire Program (HSP).

**Mare Eligibility:** Any mare regardless of the state of residence that is registered with the American Haflinger Registry and bred to a Nominated Indiana Stallion is eligible.

## Stallion Nomination

The fee to enter a new Stallion in the Hoosier Sire Program is \$100. The fee should be paid at the start of the breeding season. However, it may be paid the following year with the breeding report which is due January 31. Paying the stallion nomination fee during the current breeding season provides the advantage of having your new stallion listed on the IHHA Website as a HSP Nominated and Standing Stallion for the current breeding season.

## Fees

**Stallion owners:** \$25 per mare bred each year. Each mare bred must be listed on the IHHA breeding report. Breeding reports and fees are due January 31, of the following year. Breeding reports must be received on time to maintain your stallion advertisement on the IHHA Website.

**Mare owners:** Mare owners regardless of state of residence pay \$25 per mare bred each year. This fee nominates the foal for eligibility in the program and to show in the Indiana State Fair IHHA Hoosier Sire Show class as a yearling. The foal nomination fee is due January 31, following breeding year.

## Late Fees

A late fee of \$250.00 to nominate a weanling or yearling either purchased or owned that was not originally nominated by the mare owner or was not nominated by the owner by the January 31 deadline.

**Stallion Breeding Reports:** Any reports received from February 1 - 28 is an additional fee of \$250.00. After March 1, they will not be eligible for that year.

## Hoosier Sire Show

A copy of the AHR Registration (front & back) must be presented at the show, or sent with the show entry form.

**HSP Nominated Yearling Owners:** Fee of \$25 along with the Hoosier Sire Show Entry Form is due 1-July per the terms on the form. No late fees apply. The deadline must be met to participate in the HSP show.

All Hoosier Sire Program yearlings are eligible to show in the open class at the Indiana State Fair. Send open class entry to: State Fair Entry Department in Indianapolis by July 1, or go online at [www.indianastatefair.com](http://www.indianastatefair.com)

If the yearling is to be shown ONLY in the Hoosier Sire Program class, the horse must arrive by 9:00 A.M. the morning of the show and may leave after show. The Indiana State Fair requires a one day stall fee. It is payable at the draft horse office upon arrival. Note: The rules and fees of the ISF take precedence over IHHA printed material.

Premium checks will be mailed within two weeks after the show.

## **Premiums**

The Hoosier Sire Payout is paid as a jackpot. This means the entirety of the jackpot will be paid out regardless of the number of fillies and colts in the two HSP classes. The HSP pays a maximum of 10 placings per class.

**Stallion Owners:** Stallion owners shall receive 5% for first place, 4% for second place and 3% for third place of the applicable class jackpot.

The stallion owner IHHA Service Auction Bonuses of \$40.00 for 1st, \$30.00 for 2nd and \$25.00 for 3rd are awarded to those stallions that donate a service to the IHHA Sale, Stallion Service Auction the same year as the applicable show. The funds for this bonus are provided by the IHHA and are not taken from the Jackpot.

## **Important Dates**

Jan 31: Stallion Breeding Reports & Foal Nominations

March 1: HSP stallion lose eligibility if no breeding report was submitted.

July 1: Deadline for HSP Show Entry Form

## **HSP Example**

2016: Mare Bred to nominated stallion

2017: Stallion owners submit breeding reports for 2016 breeding season and pay fees. Mare owners submit foal nomination forms and pay fees for mares bred in 2016. 2016 Stallion Breeding Reports and Foal Nomination Forms and all fees are due 31-January, 2017.

2018: Foal owner enrolls yearling foal with the IHHA HSP using the HSP State Fair Entry Form and pays the fee, due 1-July. The foal also must be entered with the Indiana State Fair. The instructions to enroll with the ISF are included on the IHHA HSP State Fair Entry Form.
