HARBOR HOLIDAYS ARTISANS MARKET 2025 Friday, Nov. 21, 6-9 & Saturday, Nov. 22, 10-4

Agreement and Release

The exhibitor agrees to abide by the following rules as a condition for acceptance to the Harbor Holidays Artisans Market at the Boston Yacht Club:

- 1. All crafts to be displayed for sale are *hand made* and are *not* in any way **machine made**, **mass produced**, or assembled from commercially sold kits. PLEASE NOTE: New artisans applying with all handmade work will be given precedence.
- 2. The exhibitor booth will not be sublet to other persons or shared. The exhibitor will not act as a dealer or agent for other craft persons or manufacturers. Harbor Holidays Artisans Market reserves the right to remove without refund or recourse any exhibitor who misrepresents themselves or their product. Submitted Images will be used for marketing purposes. NO APPLICATIONS WILL BE ACCEPTED WITHOUT IMAGES and CHECK FOR APPLICATION AND BOOTH FEES.
- 3. Each exhibitor must comply with all local and state regulations. All display material must be fireproof. There will be no open flames without written permission prior to the show. Each exhibitor is responsible for all applicable sales tax, vendor licenses and/or state licenses.
- 4. All exhibitors are expected to conduct themselves in a manner in keeping with the high standards of the Harbor Holidays Artisans Market. "Sale" signs are not permitted. All excess stock, wrapping materials, bags, and boxes must be stored out of sight. **All exhibitors must provide their own table and covering**. Exhibitors must arrive at least one hour prior to the scheduled Artisan Market to set up and prepare their exhibit space. Any exhibitor who fails to arrive one hour before the scheduled Artisan Market forfeits his/her right to exhibit, without refund or recourse, unless written permission is obtained prior to the show. **All exhibitors must remain at the show for the entire show. Leaving early is not acceptable. SET UP-Friday, November 21, 2pm 6pm**.

There is NO onsite parking for non-members. Please be prepared to move your vehicle after you unload.

- 5. **NO REFUNDS** will be issued after September 1.
- 6. Harbor Holidays Artisans Market, its agents, officers, or volunteers will not be held liable for failure to perform or fulfill its contractual obligations provided such failure is caused or impeded by closure of the site location due to factors beyond the control of the organization. Although an Overnight front desk person will be on duty Friday night into Saturday morning, neither the Harbor Holidays Artisans Market organizers nor the Boston Yacht Club will not be held responsible for loss or damage of exhibitor's wares, exhibits, or personal property during the show. Neither the Harbor Holidays Artisans Market organizers nor the Boston Yacht Club will be held responsible for damage, loss or injury caused by products sold or exhibited by exhibitors directly or through warranty expressed or implied. Insurance for such loss, damages or injury is the sole responsibility of the exhibitor.
- 7. It is agreed that Harbor Holidays Artisans Market reserves the right to amend and/or add to the applicable rules pertaining to and governing the show at any time prior to the beginning of the show. The interpretation of all exhibitor rules by the Harbor Holidays Artisans Market volunteers/organizers for participation in the Artisan Market is final.

Agreement and Release

I understand that if my application to participate in the Harbor Holidays Artisans Market is accepted, I give the Harbor Holidays Artisans Market organizers/volunteers and the Boston Yacht Club permission to use my name, my business name, pictures of my exhibit and any other materials submitted for publicity purposes. Application to the Harbor Holidays Artisans Market at the Boston Yacht Club Artisan constitutes Exhibitor Agreement of this release.
