Larry Ring motioned to set the Fire levy at \$110,000.00 for 2023. Seconded by Nick Rueger. Motion carried.


Nick Rueger motioned to set the Road and Bridge levy at \$280,000.00 for 2023. Seconded by Audrey Felty. Motion carried.

Diane Volkert-Ring motioned to set the General levy at \$85,000.00 for 2023. Seconded by Audrey Felty. Motion carried.


