AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of Mason County Fire Protection District No. 11 from January 1, 2017 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounts payable – credit cards, travel expenditures, and employee reimbursements
- Payroll – gross wages of public officials
- Tracking and monitoring of theft-sensitive assets, such as computers, tools, equipment, and pharmaceutical inventory
- Procurement – purchases and cooperative purchases
- Self-insurance for unemployment

INFORMATION ABOUT THE DISTRICT

Mason County Fire Protection District No. 11 provides fire protection and suppression services as well as Basic Life Saving Emergency Medical Services near Shelton and the Shelton Airport.

An elected, three-member Board of Commissioners governs the District and appoints a Fire Chief who oversees two employees (one firefighter, one secretary) and about 18 volunteer firefighters. The District is primarily funded through property taxes, with revenues of about \$410,000 in fiscal year 2017 and \$445,000 in fiscal year 2018, and expenditures of about \$320,000 in fiscal year 2017 and \$330,000 in fiscal year 2018.
