<b>From Fairgrounds</b> Turn right out of fairgrounds unto SW 53 <sup>rd</sup> St. Enter the roundabout and take second exit unto SW 53 <sup>rd</sup> St. Turn left onto SW Philomath Blvd-US 20E/OR-34. Go 2.6 miles and turn left onto SW B Av. Take the first left onto SW 4 <sup>th</sup> St. and continue to follow OR-99W to 1562 SW 3 <sup>rd</sup> St. <i>4.3 miles, about 8 minutes</i>	<b>From Fairgrounds</b> Turn right out of fairgrounds unto SW 53 <sup>rd</sup> St. Enter the roundabout and take second exit unto SW 53 <sup>rd</sup> St. Turn left onto SW Philomath Blvd-US 20E/OR-34. Philomath Blvd becomes OR-34 Bypass. Turn left onto Hwy 34/OR-34. Take first right onto NW 2 <sup>nd</sup> St/US-20E, continue to follow US-20E Turn left onto NW Springhill Dr., Turn Left onto Hickory St. to Rivers Edge Pet Medical Center <i>15 miles, about 21 minutes</i>

**From fairgrounds:** Turn left out of fairgrounds unto SW 53<sup>rd</sup> St toward Campus Way. SW 53<sup>rd</sup> St becomes NW Walnut Blvd. Go about 4 miles and turn left onto NW 9<sup>th</sup> St. Turn slight left onto NW Elks Dr. Take the first right onto NW Samaritan Dr. *5.4 miles, about 10 minutes*

### Directions to Benton County Fairgrounds from I-5 either direction

**From I-5 take Exit 228** Lebanon/Corvallis unto OR Hwy 34. Go West toward Corvallis about 9.6 miles **Turn Left onto OR-34 bypass** toward Philomath which becomes SW Philomath Blvd/US-20W/OR-34 **Turn right unto SW 53<sup>rd</sup> St** pass through 1 roundabout, go about 1 mile **Fairgrounds** on the left, go to last driveway and enter gate marked Benton Oaks RV Park. Turn left at the first driveway between the Carriage House & Shop, Main Lawn is on your left just past the Carriage House.

Unreserved parking by the Carriage House and shop, but you may unload near the vehicles parked at far end of main lawn. Look for Orange Pop Up Tent to check in.
