Exhibitors MUST check-in for each trial in which they are entered. If entered in both the morning and afternoon trials check in for each at the designated time. Time listed in the this premium list are approximate and may change after entries close. Check Judging Program included with your entry confirmation for actual times scheduled.

DIRECTIONS TO THE CLARK COUNTY EVENT CENTER

From North take I-5 to exit 9 (NE 179th St.) Turn left onto NE 179th St, turn left onto NE Delfel Rd. Clark County Event Center is on the right.

From South –take I-5 to exit 9 (NE 179th St.) Right onto NE 179th St, left onto NE Delfel Rd. Clark County Event Center is on the right.

GENERAL SITE RULES

Trial Site. It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future. (Chapter 3, Section 15 of the Scent Work Regulations).

Possession of Odors and Training. Chapter 5, Section 35 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

Dog exercise Area Grass areas that are not posted on the grounds. You must pick up after your dog. Dogs must remain on leash at all times and handlers must practice social distance of at least 6 feet between humans.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites at various locations around the show grounds.

Unloading and Parking You may enter the gates to unload outside the Staging area then return to the parking lot promptly. No parking inside the gates without a parking pass provided by the Events Center.

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be **judged**. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the search area when required.

ENTRY FEES

An entry is defined as a single run by a single dog in a single class. Entry fee includes a \$3.50 per run AKC recording fee.

Returned Checks/Declined Transactions Trial Secretary will add a \$25 service charge for any returned check or declined credit card transaction. Subsequent returned checks from the same exhibitor may result in being placed on a CASH ONLY basis.

Illegible entries will not be processed and will be returned to the exhibitor. Returned checks and declined credit card transactions do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of such entries. **ALL checks received will be deposited and must clear to be considered a valid entry.**

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. **Dogs pulled after closing** because of injury or other medical condition are not eligible for a refund.

Bitches in season will be refunded the full entry fee less a \$5 per trial processing fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of each trial. Refunds will be mailed after completion of the trial.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

SEARCH AREA AND RING CONDITIONS

Search Area Conditions. Searches may be indoors, on matted, carpeted, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces. This facility is ADA accessible throughout.

Search Area Sizes Refer to the Scentwork Regulations for search area sizes and other requirements. Search areas may be of any shape and of the size specified in the Regulations for each class.

<u>Exhibitors MUST check-in for each trial in which they are entered.</u> TimeS listed are approximate and may change after entries close or on the day of trial. Check schedule included with your entry confirmation to be sure.

CLASSIFICATIONS

Novice A Classes are open to dogs who have not completed any title for that particular element, who have not completed a comparable title with another organization, and whose handlers are neither Scent Work judges, nor have ever worked as professional detection dog handlers.

Novice B Classes are open to all dogs.

Advanced Classes are open to dogs who have achieved the Novice title for that particular element.

Excellent Classes are open to dogs who have achieved the Advanced title for that particular element.

Master Classes are open to dogs that have achieved the Excellent title for that particular element.

Detective class is open to dogs who have achieved a Master title in any Odor Element.

Handler Discrimination classes are titling classes in which the targeted scent is that of the handlers themselves. Handlers are required to provide their own scented articles in a plastic bag. For the Novice class, one cotton glove or cotton sock, for Advanced, Excellent, and Master, cotton balls or cotton swabs. Three qualifying scores are required to earn titles in each class. Handlers may utilize any method to scent their article except by applying oils used for Odor elements. Suggestions include rubbing the article on the handler's body or storing the item in dirty laundry.

Dogs may enter up to two (2) difficulty levels in each element, in each trial. Dogs may only enter a class once in each event. A class is defined as a particular difficulty level within a particular element, For example, a dog may run in both Novice B and Advanced Interior in the same trial, but may not run in Novice Interior twice in the same trial. Dogs may only enter classes for which they are eligible according to the above guidelines. Dogs that have previously earned the same or higher level AKC Scent Work titles may also enter lower level classes.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.

Dogs with physical challenges Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge. (Chapter 2, Section 3 of the Scent Work Regulations).

STAGING AREA, HANDLER BRIEFING, WARM-UP INFORMATION

Staging Area will be in South Hall 1. You will be able to set up in the designated area Friday after 4 pm. Crates and gear may be left overnight but must be out of the building no later than one hour after end of judging on SUNDAY. Staging for Monday will be in your vehicles. Check-in, Transfers, and briefings will all start here. There will be more details in the judging program.

A **Handlers Briefing** will be a group briefing prior to the start of each day's judging in the staging area and will include a walkthrough of the search areas. Judge will also brief you as you enter the search area.

Warm-up Area One labeled container per target odor being used in the trial on that day will be placed in the staging area. This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area as well. The warm-up area is not for training or relieving of the dog. (Chapter 5, Section 34 of the Scent Work Regulations).

RIBBONS, AWARDS, AND PRIZES

All prizes and ribbons must be claimed day of the trial. None will be mailed or otherwise distributed.

Placement ribbons will be awarded in each class as follows:

First Place	Blue
Second Place	Red
Third Place	Yellow
Fourth Place	White
Qualifyina Score	Dark Green

A special qualifying ribbon will be awarded each team qualifying in Detective

A **New Element Title rosette** will be awarded to teams finishing an Element title.

A **New Level Title rosette** will be awarded to teams finishing a Level title.

High in Trial (HIT) Teams earning High in Trial in each level will receive a HIT rosette. (Offered at all events)

Only teams who participate in all elements in the same difficulty level offered (Container, Interior, Exterior, and Buried), and qualify in each element, are eligible to win **High in Trial**. One HIT winner is chosen for **each level**; there is not a separate HIT for the Novice A and Novice B sections. The HIT is determined by adding each team's faults across the elements.

<u>High Combined Division Trial (HCD)</u> Teams earning High Combined Division in each level will receive a HIT rosette. (Offered Saturday & Sunday only)

Only teams who participate in all elements including Handler Discrimination in the same difficulty level offered (Container, Interior, Exterior, Buried, and Handler Discrimination), and qualify in each element, are eligible to win the HCD award. One HCD winner is chosen for **each level**; there is not a separate HCD for the Novice A and Novice B sections. The HCD is determined by adding each team's faults across the elements.

Ties If there is a tie based on faults for any award, then each team's times across the elements will be summed and the faster-finishing team wins.

SPECIAL HIGH COMBINED AWARD Teams competing in Detective and at least three Master level elements may earn a Special High Combined in Trial award by qualifying in all elements entered. Team with the least faults and most Qualifying scores each day will earn this award. If there is a tie it will be broken by each team's times across the elements will be summed Then divided by the number of Q's. Team with the shortest average time per Q wins. **Offered Sunday & Monday**

Job Descriptions

Note: many volunteer positions require walking, standing and bending. *May be sit down jobs.

Chief Steward – organizes, trains, deploys volunteers throughout event. May also work the gate or score table.

Element Set up – Ensures all setup is complete for assigned Element, at the Judges direction, including line of site, start lines, boundary marking. *Friday afternoon, Saturday afternoon, Sunday afternoon*

Clean up – Site preparation for the next day, removal and loading of all trial gear at Trial(s) completion.

*Timer – Timing competitor runs. Timer may not time a class in which he or she is exhibiting.

*Gate Steward – Managing flow for the trial element area, assisting competitors positioning pre-search.

*Judges Steward – Bring competitors to the start line, remind them of the time limit and leash options for the search. Cleanup between competitors may be required, including sweeping, vacuuming, or returning spilled sand to the container, and mopping slopped water.

HD Hide Steward (includes Hot Box Steward) must wear latex or nitrile gloves when handling odor containers/boxes, etc. to prevent contamination Handles and places hides for handler scented item at the Judge's direction.

Score Runner - carries score sheets from search areas to Score Table throughout the trial.

*Registration – Check in of arriving Competitors and Volunteers. Assistance at Score Table with verification of score sheet completion before data entry.
