

JUNIOR SHOWMANSHIP COMPETITION

NOVICE JUNIOR CLASS - For Boys and Girls at least 8 and under 12 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

NOVICE INTERMEDIATE CLASS - For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

NOVICE SENIOR CLASS - For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

OPEN JUNIOR CLASS - For Boys and Girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

OPEN INTERMEDIATE CLASS - For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

OPEN SENIOR CLASS - For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

MASTER CLASS - For Boys and Girls at least 9 and under 18 years of age on the day of the show and who have won ten (10) Best Junior Handler awards with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed, all participants return to the Open Class to compete for the following year.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 233-9767.

BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

While champions may not be entered in the breed classes at a dog show match, they may be handled in the Junior Showmanship classes

No dog with the CDX or equivalent title may compete in any regular class at an OA or OB sanctioned match except Utility. Such dogs may be entered and participate in the Open B class, but may not compete for any awards in that class.

No dog with the UD or equivalent title may compete in any regular class at an OA or OB sanctioned match. Dogs with the UD title may be entered and participate in the Open B or Utility classes, but may not compete for any awards in these classes.

RALLY MASTER

BITCHES IN SEASON ARE NOT PERMITTED TO COMPETE IN OBEDIENCE OR RALLY. If a bitch is withdrawn from competition because she came into season and the Match Secretary is notified in writing at least one-half hour prior to the start of the event, the club will refund entries withdrawn under this fee section.

THERE SHALL BE NO DRILLING NOR INTENSIVE OR CORRECTIVE TRAINING OF DOGS ON THE MATCH GROUNDS OR PREMISES.

ALL DOGS shall be kept on leash except when in the Obedience, Rally, or warm-up rings.

ADDITIONAL INFORMATION

IF THE SAME DOG IS ENTERED in more than one class, the highest priced class shall be considered the first entry.

MAKE ALL CANADIAN CHECK OR MONEY ORDERS payable in U.S. Funds. **CONDITIONAL, UNSIGNED, INCOMPLETE, OR ENTRIES RECEIVED WITHOUT**

FEES WILL NOT BE ACCEPTED.

OWNERS ARE RESPONSIBLE for errors on entry blanks and for entering the same dog twice.

ENTRIES NOT ON OFFICIAL AKC FORMS or photocopies of entry forms without rules and agreement on reverse side of Official AKC entry form are **NOT** acceptable.

NO DOG WILL BE ALLOWED IN THE MATCH AREA EXCEPT THOSE REGULARLY ENTERED IN THIS MATCH.

DOGS MUST BE READY FOR JUDGING. The club and its Match Secretary will not be responsible and are not obligated to furnish any service for notifying exhibitors or their agents of breed or class judging. Judges will not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging ring.

DOGS NEED TO BE AT THE MATCH only at scheduled time of judging and may leave immediately thereafter, unless required for further judging.

THE MATCH-GIVING CLUB, MATCH SECRETARY, THEIR AGENTS, AND EMPLOYEES assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
