November 24, 2018	Intro to AKC Scent Work seminar including Handler Discrimination at My Dogs Gym in Salem, Oregon. Limited to 5 and all slots filled. Instructors Judi James & Susan Smith.
November 25, 2018	Container-RAMA (Scent work practice match) at My Dogs Gym in Salem, Oregon. We had 9 exhibitors and 20 runs of 4 elements each run. 5 club members organized, judged, and stewarded match.
December 1-3, 2018	<p>Greater Clark County KC Scent Work events at Clark County Fairgrounds, Battle Ground, WA. This event was well supported by exhibitors from all over Oregon & Washington, but the club lacked knowledgeable members on the ground to run the event. Many exhibitors stepped up to organize and manually process paperwork, stewards, and score table through the weekend.</p> <p>We offered membership applications and match flyers to all and accumulated 22 applications for the new Scent Work club over the weekend.</p>
