## NOTICE TO EXHIBITORS

***Pandemic Guidance – If you are fully vaccinated, you need not wear a mask in Oregon any longer. However, COVID-19 cases are on the rise again in Oregon and we encourage you to use a mask when likely to be within a group of other people or within six feet of another person not in your immediate circle.***

***DOG HEALTH WARNING –AKC rules prohibit any dog being brought unto the grounds of a dog show which may show clinical symptoms of a communicable disease or been in contact with a communicable disease within the last 30 days. There has been an outbreak of Kennel Cough in the Bend, Oregon area recently. Signs of communicable disease may include coughing, sneezing, wheezing, runny nose, loss of appetite, fever, or diarrhea. If your dog isn't well, please keep it home.***

### **SAFETY, BEHAVIOR and LIABILITY**

**The safety of the dog** is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. Greater Clark County Kennel Club, Pacific NW Scent Work Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. Pacific NW Scent Work Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Pacific NW Scent Work Kennel Club, or any official thereof.

**Dogs found in an unsafe** environment, distress or harm's way such as in a **hot motor vehicle** will be removed to safety by Club officials or security personnel. Exposing a dog to an unsafe environment, distress or harm's way will be investigated by the Event Committee. All persons attending this event waive any claim for damages against the Clubs, their members or agents, in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.

**All dogs must be on leash** at all times, and **retractable leashes may not be used when on trial grounds (except during judged searches).**

Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

**Fire Lanes and designated areas must be kept clear. No parking in these areas.**

**Judges are not required** to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the search area when required.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.



## STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

**PARKING** All parking will be OUTSIDE the Yellow Gate in the strip between Silverton Road & the Fence. You may pause immediately outside the Yellow Gate to unload, then move to a parking space. No parking inside the Yellow Gate without permission of event chair. Self-contained RV's may park overnight in this area, but be aware of undergrowth that may be flammable. Please respect space around your vehicle to have at least six feet distance at all times.

**STAGING AREA** will be in your vehicles. YOU MAY ALSO SET UP canopies and crates inside the Yellow Gate in the picnic grove (shady grass area) just to the left of the gate. The Fairgrounds has given permission to leave canopies set up overnight, but assumes no responsibility for lost, damaged, stolen gear left overnight. The gates are not locked before 7 pm. Everything must be gone including trash by 7 pm Sunday evening.

**EXHIBITOR CHECK IN** is just past the first building (4-H Pavillion) on the right. Look for the Orange and Blue tents. Secretary drop box will be there as well as the Check-in boards, posting of daily run order, results and self-service ribbons. If you finish a title, let the crew there know and they will prepare a new title ribbon for you. There will also be a cooler with ice and water for everyone to share.

**Warm-Up Area** will be across the driveway from Check in. One labelled container per target odor used in the trial on that day will be placed in the warm-up area. This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area as well. The warm-up area is not for training or relieving of the dog. (Chapter 5, Section 34 of the Scent Work Regulations).

The waiting area (line) will also be in this area but may adjust throughout the day to follow the shade. We will also have a splash pool for dogs in this area.

**PUBLIC RESTROOMS** are in the Hart of the Garden (aka Floral) Building immediately adjacent to the check in area. Unfortunately, they are at the FAR end of that building and you will need to walk across the lawn to get there.

**Dog exercise Area** – will be the grass areas along Silverton Road and grass inside the Yellow Gate. Dogs must remain on leash at all times and handlers must practice social distance of at least 6 feet between humans. This is also an area where RV's may park, please respect their space around vehicles of at least six feet at all times. No parking inside the Yellow Gate without permission of event chair.

A **General Briefing** will be conducted onsite by trial chair daily outside the Orange pop-up See schedule for time.. **Handlers Briefings** may take place at the same time at Judges discretion.

**Trial Site.** It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future. (Chapter 3, Section 15 of the Scent Work Regulations).

**Possession of Odors and Training.** Chapter 5, Section 35 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

**Exhibitors are responsible for cleaning up after their dog(s).** Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.
