Each event, based on event number, requires a separate report. For example, back-to-back shows, two-in-one-day shows, and standalone Obedience each require their own report. Please answer all questions; if additional space is needed please attach 8.5"x11" paper only. This report should not be used for FSS Open Shows and 4-6 Month Beginner Puppy competition as they have own **report**.

Per Rules Applying to Dog Shows, Chapter 11, Section 2, recording fees are \$0.50 and Service Fees are \$3.00 for a dog's first entry.

There is a \$3.50 service fee for each additional entry by a dog.

(Points mentioned must be observed in each instance.)


1. All absentees in each class in this book must be marked by the judge.
2. The judge alone must mark this book and hand out ribbons. Under no circumstances can this be done by the steward or anyone else.
3. Ribbons must be presented in the ring. If the owner of handler has left the ring before ribbons are given out, do not follow him; send an attendant to bring him back into the ring.
4. Be sure and line up the dogs, first, second, third, fourth, before handing out the ribbons. The public is entitled to know the order in which the dogs will be placed.
5. Do not forget to sign your name at the bottom of this page to meet the certification that judging has been made in accordance with the above requirements.




