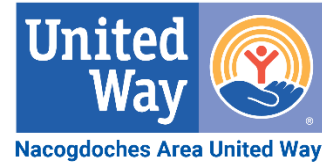

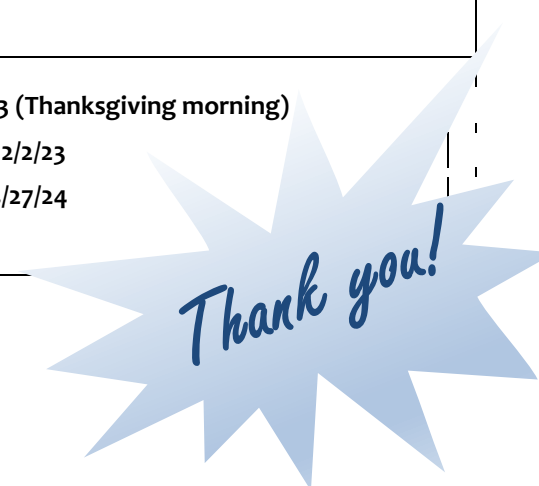

Entries must be postmarked before October 31, 2023.
6. All verified entry forms must be received by November 6, 2023, to be eligible for the drawing.
7. Employees, members of the Board of Trustees of the NAUW, and their immediate families are not eligible to participate
8. Following the drawing and verification of eligibility, the winner will be notified and a public announcement will be made. Proper identification and proof of insurance will be required upon presentation of this prize. Eligible individuals need to be present to win.
